MANAGEMENT SERVICES

Mrs. Mowrey, Chairman of the Management Services Committee, gave the report of her committee and introduced Mr. Drew Becker from Grand Prairie Friends. Mr. Becker said his 501C organization may be interested in the purchase of the 40 acres of County-owned timber. He said they would clear out the exotic and invasive plant species and add trails. He said it would be beneficial to County residents, in that they would be able to utilize the property in nature-related ways. As the property is now, only poachers are taking advantage of it.

Because there is some opposition to the sale of any County-owned land, Mr. Becker said he would meet with his group to see if there would be any interest in a long-term lease, although he thought this would be unlikely.

Your committee met at the Administrative Center on March 9, 2009 at 9:00 A.M. Members present were Harriett Mowrey, Beryl Luecke, Jim McCray, John Dowling, Jean Hiles, Dennis Johnson, Donna Wasmer, and Alan DeWitt. Also present were Ron Schroeder, County Board Chairman; Sheriff Eldon Sprau; Maintenance Supervisor Larry Pankey; Drew Becker from Grand Prairie Friends; Ken Barragree, IDA Director; Sherry Johnson from the City of Watseka Park District; and Mr. Ficke, Treasurer of the Old Courthouse Museum Historical Society Board.

Chairman Harriett Mowrey called the meeting to order. She reported the County has received the County Farm cash rent from Walker Farms in the amount of \$33,821.50 which they pay in March and October.

Ken Barragree from Iroquois Development Association and a Board Member of the East Central Illinois Economic Development District Agency was present to offer information about an energy grant. Mr. Barragree will submit the grant at the direction of the Management Services Committee. He said through IDA's membership, the County has 60 hours of free consultation time of University of Illinois engineers who would assess County buildings, identify problems on anything to improve energy conservation and prepare a detailed report to the County. After completion of the grant it could take up to 6 months to be approved.

Harriett Mowrey, Management Services Chairman; Susan Wynn Bence, County Board member and Larry Pankey, Maintenance Supervisor, have been working on a grant through the Illinois Clean Energy Community Foundation. Counties are eligible to apply for funding to pay for energy-savings upgrades. Grants are limited to no more than \$30,000 per building. Three County buildings will meet the requirements - Jail for Public Safety, Administrative Center houses the 911 Department, and Old Courthouse Museum. This is a 80/20 grant. John Dowling, Health Services Chairman, said State's Attorney Jim Devine is researching the possibility of borrowing from the Solid Waste Fund since it is an Environmental issue - GO GREEN to fund the upfront costs. It was moved by Jean Hiles and seconded by Jim McCray to proceed with the upgrades. Motion carried.

Maintenance Supervisor Larry Pankey said he has received a letter from Urban Elevator Service, Champaign, IL stating they have received a signed proposal, dated April 15, 2008, from the County for the work to be performed on both the Otis elevator and the dumbwaiter. Urban's policy is to honor the amount stated on the proposal for a 90 day period, the repair work was re-calculated as materials and labor cost have increased. This would be a \$400 elevator increase and \$250 dumbwaiter increase to original proposal. The new totals are \$7,600 (up from \$7,200 for the elevator and \$3,250 (up from \$3,000) for the dumbwaiter. It was moved by Jim McCray and seconded by Dennis Johnson to approve the amended proposal. Motion carried.

Nita Dubble, 911 Coordinator, said she has been in contact with A T & T telephone service. The present telephone service with Access One is unacceptable. The option County employees have to do County business is by using their own cell phone.

Sheriff Eldon Sprau wanted to thank Larry Pankey, his crew, and the help of two jail trustees for painting the entire inside of the jail and replacing energy efficient light bulbs.

The committee reviewed the claims. It was moved by Donna Wasmer and seconded by John Dowling to pay the bills subject to County Board approval. Motion carried. It was the consensus of the committee to withhold payment of the Access One telephone bill until the telephone service issue is resolved.

Drew Becker from Grand Prairie Friends, Urbana, IL represents the not-for-profit corporation interested in purchasing and conserving as a natural habitat the 37.9 acres of timber owned by County. Mr. Becker said the property has unique plants that vary in species and also a sand pond that is rare. The organization shares a commitment to preserve and restore tallgrass prairies, wetlands, savannas and forests in east-central Illinois. They would pay fair market price. It was suggested that an appraisal be made and explore the idea. This group does have a viable plan. Mr. Becker was asked to come to the County Board meeting on March 10, 2009 at 7:00 P.M. to answer questions.

Sherry Johnson from the City of Watseka Park District and Mr. Ficke representing the Old Courthouse Museum were present to express interest in helping to get grants and organize fund raisers to maintain the Old Courthouse. A copy of the original lease between the County of Iroquois and the Iroquois County Historical Society will be obtained to determine who has what responsibilities.

It was moved by Donna Wasmer and seconded by John Dowling to adjourn at 10:35 A.M. Motion carried.

Your committee met at the Administrative Center on March 3, 2009 at 9:00 A.M. Members present were Dale Schultz, Troy Krumwiede, Betty Busick, Lowell Schmidt, Ernest Curtis and Merle Lemenager. Also present were Ron Schroeder, County Board Chairman; Mindy Kuntz Hagan, Treasurer; Cecilia Dixon, Director of Data Processing; Dr. James Finnell, Animal Control Administrator; Tom Tuntland, Director of County Information Systems; Gloria Schleef, Planning & Zoning Administrator; Mark Henrichs, County Clerk, Joedy Smith, Project Manager with DEVNET, Wendy Davis from the Times Republic; and Mike Moran.

The meeting was called to order by Committee Chairman Dale Schultz. Mr. Schultz said he has conferred with Chairman Schroeder and at this time would like to announce that Troy Krumwiede has been appointed Vice-Chairman of the committee.

The committee reviewed the claims. It was moved by Merle Lemenager and seconded by Ernest Curtis to pay the bills subject to County Board approval. Motion carried.

Tom Tuntland, Director of County Information Systems reported he continues to work with DEVNET.

Joedy Smith, Project Manager of DEVNET, distributed an update of the proposed implementation plan revised February 27, 2009. On March 5, 2009 they will complete Mobile Home Maintenance/Create 2009 Mobile Home Tax Bill File, train on Mobile Home Collection on March 6th in the Treasurer's Office and mail Mobile Home tax bills on March 9, 2009. Last year approximately 638 Mobile Home tax bills were mailed the first week of March. The tax cycle is on schedule with the implementation of the new system.

Gloria Schleef, Planning & Zoning Administrator, requested that her office have the capability of two (2) mainframe connections. Tom Tuntland, Director of County Information Systems said of the six (6) CPU's in the office only one (1) is capable of handling DEVNET. The parcel lookup is vital when a permit is requested and floodplain maps are requested. The funds are available in the Planning & Zoning Capital Expense budget. It was the consensus of the committee to authorize the purchase a new CPU costing approximately \$400.00.

Bob Yergler, Supervisor of Assessments, reported the Board of Review is out of session and the final abstracts will be sent to the Illinois Department of Revenue March 13, 2009. The County will wait for the final multiplier. Mr. Yergler said he will have input to support bills pertaining to the Assessment Office as he is now a member of the Certified County Assessing Officials Board.

Dr. James Finnell, Animal Control Administrator asked if the committee had any questions on the claims or the monthly activity report. He reported the dog registration fees are up by 8.6%.

Ron Schroeder, County Board Chairman, said the Policy and Procedure Committee will meet on March 10, 2009 at 5:30 P.M. before the regular County Board meeting. The meeting will be posted and cards sent.

Mark Henrichs, County Clerk, reported his office is busy with the upcoming election. He said he attended a Zone meeting and the average ballot styles are between 25 - 40. Iroquois County for this election has 134 ballot styles. The County Clerk's office is waiting on Mobile Home information from the County Assessors in Belmont, Sheldon, and Loda Townships.

Mr. Henrichs will be sending a letter to State's Attorney Jim Devine for an opinion on the TIF I issue. The City of Watseka has amended their TIF I ordinance to allow the full statutory period of 23 years which would extend through December 31, 2010 instead of ending in 2009. The County's opinion is that the TIF I disbursements end in 2009. The Court will make a Declaratory Judgement ruling.

Mr. Henrichs also said he has contacted the County's insurance agent, Roger Schuldt of Schuldt Insurance, concerning coverage for the 22 generators purchased with a HAVA grant, that will be in Township custody. A County inventory ID# has been attached to all the generators and Big R will record who picks up the generators and fax information to the County Board Office. Mr. Schuldt preferred the County's insurance cover the generators rather than TORMA. The township will be responsible for the maintenance, care and testing of the generators. The County will keep two or three.

The committee members and Mark Henrichs, County Clerk, discussed who will pay for the fee study required to increase fees for birth and death certificates, marriage license and redemption fees. During the budget hearings in August of 2008, \$50,000 was incorporated into the revenue side in the County Clerk's Fees line of the General Fund for an intended increase in these fees. It was moved by Lowell Schmidt and seconded by Betty Busick to authorize County Clerk Mark Henrichs

to do the fee study costing \$4,000.00. Cost of the study will be taken from the revenue side of the County Clerk's Fees line item. The County will receive a written report showing the fee increases. Motion carried. Mr. Henrichs said he will have a contract available at the March 10, 2009 County Board meeting for approval.

It was moved by Betty Busick and seconded by Troy Krumwiede to adjourn at 10:25 A.M. Motion carried.

Your committee met at the Courthouse on March 4, 2009 at 9:00 A.M. Also present Ron Schroeder, County Board Chairman; Harriett Mowrey County Board Vice-Chairman; Sheriff Eldon Sprau; Lisa Hines, Circuit Clerk; Bill Cheatum, Coroner; Carl Gerdovich, ESDA Coordinator; Barb King, Probation Supervisor; and Jim Devine, State's Attorney. Also present Wendy Davis from the *Times Republic*; and Mike Moran. Lisa Hines, Circuit Clerk, distributed her monthly disbursement report for February 2009. Fines were up approximately \$10,000. The Ordinance to increase the Automation Fee to \$15.00 and Document Storage Fee to \$15.00, and initiate an Arrestee's Medical Cost Fee of \$10.00 for each defendant at the time of order of conviction or supervision has an effective date to commence March 1, 2009.

Sheriff Eldon Sprau submitted a copy of the grant his department has received for bullet proof vests in the amount of \$8,816 that must be expended by September 30, 2010. The copy will be placed on file. As he reported in December of 2008 this grant lowered the budgeted line item from \$28,000 to \$20,000, a savings of \$8,000.

Barb King, Probation Supervisor, reported that Rick Einfeldt, Director of Court Services 21st Judicial Circuit, will retire as of June 1, 2009. The GPS contract has expired as of yesterday, March 3, 2009. The Probation Supervisor and Sheriff Eldon Sprau are working together with Secure Alert to renew the contract. There will be \$.25 increase for each device. Ms. King discussed the Bischoff's Law briefly.

Carl Gerdovich, ESDA Coordinator, reported Iroquois County's Hazard Mitigation Grant Program Grant Application has been approved by FEMA. The grant agreement provides funding to the County for its efforts to develop a FEMA-APPROVED Disaster Mitigation Act of 2000compliant mitigation plan. This Grant Agreement in the amount of \$74,500 will serve as the contract between the IEMA and the Subgrantee (County of Iroquois ESDA) for the purpose of developing an approved and adopted DMA2K plan This amount represents the 75 percent Federal share of the cost of the **planning** initiative. The Subgrantee (County of Iroquois ESDA) will provide all necessary financial and managerial resources to meet the terms and conditions of receiving HMGP (Hazard Mitigation Grant Program) funds.

Carl Gerdovich also reminded the Judicial and Public Safety committee and elected officials present of the State-Wide ESDA exercise scheduled for June 4, 2009.

Bill Cheatum, Coroner, reported for the month of February 2009 - 2 autopsies were performed - 17 deaths (7 death certificates signed by the Coroner's office and 10 death certificates signed by physicians) and 6 cremation permits were issued.

The committee briefly discussed the 22 generators acquired through a HAVA Grant submitted by the County Clerk. It was suggested that a few of the generators be available to be used in the EOC room located in the basement of the Courthouse and other County departments, such as Highway Department, during a power outage. No decision was made until further investigation.

Jim Devine, State's Attorney, had no report. He is waiting for detailed bills from the expert witnesses who testified at the murder trial.

Your committee met at the Administrative Center on March 5, 2009 at 9:00 A.M. Members present were Jim Meyer, John Dowling, Rod Copas, Russell Bills, Harriett Mowrey, Charles Alt, Kevin Hansen and Susan Wynn Bence. Also present were Ron Schroeder, County Board Chairman; Sheriff Eldon Sprau; Tom Tuntland, Director of County Information Systems; Bob Yergler, Supervisor of Assessments; Gloria Schleef, Zoning Administrator; Cecelia Dixon, Director of Data Processing; Carl Gerdovich, ESDA Coordinator; Mindy Kuntz Hagan, Treasurer; and Larry Pankey, Maintenance Supervisor. Also present were Wendy Davis from the *Times Republic*; Mike Moran; Mary Quinn representing the Heartland Spa; and three owners of Super 8 Motel in Gilman.

Finance Chairman Jim Meyer called the meeting to order.

Roger Schuldt of Schuldt Insurance, the County's insurance agent, gave his report.

Mary Quinn, representing the Heartland Spa, introduced herself and said she was at this committee to get answers to questions about the Hotel Operators' Occupation Tax. The Statutory Reference 35ILCS 145/1 to 145/10 defines the tax as - **The tax is imposed on the occupation of renting, leasing, or letting rooms to persons for living quarters for periods of less than 30 days**. Ms. Quinn said the Heartland Spa programs include stress management, bereavement counseling,

personal nutrition, wellness, etc. Ms. Quinn said she felt the tax could not be implemented on services. The committee said it was premature at this point until the Illinois Department of Revenue's standards and guidelines are clarified. The City of Watseka and Gilman Hotel/Motel Operators' Tax are at their maximums. Chairman Jim Meyer recognized the owners of the Super 8 Motel in Gilman, IL who are in inside the municipality's corporate limits. The committee will continue researching the tax.

Lisa Graham, Kim Gray, and Cathy Perzee, owners of the The Gathering Shop, Inc. in Gilman, II were recognized by Chairman Jim Meyer. They have completed the application for financial assistance through the County's Revolving Loan Fund. The funds recaptured from a CDAP economic development loan project have been deposited into an economic loan account. This money will be loaned to business firms to use for economic development. The loan's interest rate would be not less than three (3) percent nor exceed two (2) points below a double-digit prime rate with negotiable terms - maximum term twenty (20) years. Ms. Graham said the funds would be used to expand their current business and refurbish the building to bring two additional businesses to the community which will retain and create new jobs. It was the consensus of the committee that they agreed in principal with loaning the money. This request is the objective of the Revolving Loan Fund. It was moved by John Dowling and seconded by Rod Copas to proceed with the loaning of funds in the amount \$85,000 to The Gathering Shop, Inc. contingent on the final approval of the full County Board held on March 10, 2009. Roll call vote. Bills, aye; Alt, aye; Hansen, aye; Mowrey, aye; Dowling, aye: Wynn Bence, aye; Copas, aye; Meyer, aye. Motion carried unanimously.

It was moved by Susan Wynn Bence and seconded by John Dowling to set the interest rate at 4% and a negotiable term of no more than 7 years for \$85,000 loan through the Revolving Loan Fund to The Gathering, Inc., Gilman, IL. Roll call vote. Bills, nay; Alt, aye; Hansen, aye; Mowrey, aye; Dowling, aye; Wynn Bence, aye; Copas, aye; Meyer, aye. Motion carried. State's Attorney Jim Devine will be contacted to prepare the loan agreement for the March 10, 2009 County Board.

The Bureau of Justice Assistance has notified Iroquois County that they will receive an \$8,816.44 award under the Fiscal Year 2008 Bulletproof Vest Partnership solicitation. The grant was submitted by Sheriff Eldon Sprau's department. The deadline to request payments from the FY 2008 award funds is September 30, 2010.

Larry Pankey, Maintenance Supervisor, said he has been working with Management Services Chairman Harriett Mowrey and County Board member Susan Wynn Bence to write a grant request through the Illinois Clean Energy Community Foundation. Counties are eligible to apply for funding to pay for energy-savings upgrade to lamps, ballasts and/or controls in existing indoor lighting systems. Grants are limited to no more than \$90,000. The deadline for the grant is March 17, 2009. Susan Wynn Bence said according to the grant the County has to match up to \$18,000. The Management Services committee who meet on March 9, 2009 will discuss and recommend how to fund the \$18.000.

Supervisor of Assessments Bob Yergler reported the Board of Review has recessed and the final abstracts will be sent to the Illinois Department of Revenue on March 13, 2009.

Carl Gerdovich, ESDA Coordinator, briefly discussed the Illinois Emergency Management Agency State-Local Hazard Mitigation Grant. The Grant \$74,500 will serve as the contract between the IEMA and the Subgrantee (County of Iroquois ESDA) for the purpose of developing an approved and adopted plan. This amount represents the 75 percent Federal share of the cost of the planning initiative. Total estimated cost of incorporating the mitigation planning is \$99,550.

Zoning Administrator Gloria Schleef had no report.

Cecelia Dixon, Director of Data Processing, distributed an updated report for the office. Rod Copas said he was concerned about how and if the County was transferring the Automation Fees to the General Fund correctly. Mr. Copas suggested the county's auditor be contacted for clarification.

Your Committee met at the Administrative Center on March 6, 2009 at 9:00 A.M. Members present were Merle Lemenager, Jim Meyer, Troy Krumwiede, Donna Wasmer, Donna Crow, Beryl Luecke, and Dale Schultz. Also present were Zoning Administrator Gloria Schleef and Assistant Zoning Administrator Debbie Wright. Others attending were Regional Planning member Mike Moran, State's Attorney Jim Devine, County Board Chairman Ron Schroeder, and Wendy Davis from the Times Republic.

Ms. Schleef said she researched wind tower fees from other counties. Ford County charges \$5,000.00 per tower. Kankakee County charges \$8,000.00 for a 1.5 megawatt tower and \$11,000.00 for a 2.5 tower. Some counties charge \$25.00 a foot for the height of the tower and some charge \$25.00 a foot for the height of the tower including the blade. After a lengthy discussion, Donna Wasmer made **a motion to adopt a fee of \$5,000.00 per tower**. James Meyer seconded this motion.

A roll call vote was taken. Voting "aye" were Donna Crow, Merle Lemenager, Beryl Luecke, James Meyer, Dale Schultz, and Donna Wasmer. Voting "nay" was Troy Krumwiede. Motion was approved. Mr. Krumwiede felt the fee should be higher.

Ms. Schleef said there has been a lot of interest in personal wind towers. At the present time, there is nothing in the Ordinance pertaining to this. No action was taken at this time.

Ms. Schleef put up an overhead of the existing building permit fees. There was discussion on existing building permit fees but no action was taken at this time.

The Scott Rosenberger request was discussed. The Committee decided Mr. Rosenberger could request a B-1 zoning and go through the process with no additional cost.

Ms. Schleef said she has received a lot of calls regarding other businesses in the country and questioning if their zoning was correct.

Dave Perzee's shed on the river was discussed. Pictures were shown last month of partitions being built inside the shed. When it had been red-tagged previously, the plumbing had been moved to one end of the shed. Weber's Plumbing had been there for at least two days. Mr. Perzee had previously asked a Board member to finish out his house within the shed. The Board member had declined. Ms. Schleef believes Mr. Perzee is working on the inside himself. Mr. Devine said he had sent a letter to Mr. Perzee Wednesday and has not had a response. Mr. Devine said he is encouraging Mr. Perzee to contact him publicly so this can be worked out. Mr. Devine thought Mr. Perzee should be given time to contact him but he would continue to go forward with this.

Ms. Schleef said she would be at a Flood Plain Seminar next Wednesday and Thursday. The Seminar is in Champaign; she will be driving back and forth.

Ms. Schleef said there has been discussion previously regarding not having requests start at Regional Planning but using them to do the Land Use Map. Ms. Crow said she would like to see something decided and use them on an as needed basis. Mr. Meyer agreed. Mr. Schultz said he would like to go on record that, if Regional Planning is used only on an as needed basis, he would want the County Board to remember that this was done if cuts are decided to be done across the board.

Ms. Crow made a motion to reduce Regional Planning Commission meetings to an as needed basis for purposes determined by the Planning & Zoning Committee. Ms. Wasmer seconded this motion. Mr. Schultz said the Zoning Ordinance will need to be changed. Mr. Devine said it would have to go through public hearings.
