#### NOMINATIONS FOR VICE CHAIRMAN

County Board Chairman Ron Schroeder asked for nominations for County Board Vice Chairman. It was moved by Mrs. Wynn Bence and seconded to nominate Harriett Mowrey as County Board Vice Chairman. It was moved by Mr. Johnson and seconded to nominate Dale Schultz as County Board Vice Chairman. It was moved by Mr. DeWitt and seconded to close the nominations. Motion to close nominations carried by a voice vote. County Clerk Mark Henrichs called the roll, asking each member to state the name of the nominee of their choice for Vice Chairman. The roll being called the following members cast their vote for the first nominee, Mrs. Mowrey: Alt, Busick, Crow, Hiles, Kuntz, Meyer, Mowrey, Pursley, Schmidt, Wasmer, Wynn Bence. The following members cast their vote for the second nominee, Mr. Schultz: Bills, Copas, Curtis, DeWitt, Hansen, Johnson, Krumwiede, Lemenager, McCray, Schmid, Schultz. The vote being tied at eleven (11) to eleven (11), Chairman Schroeder was called to break the tie. Chairman Schroeder cast his vote for Mrs. Mowrey. He stated both nominees are good Board members and good choices; however, Mr. Schultz is from the same County Board District as himself. He felt it wiser to elect a Vice Chairman from another area of the County. Mrs. Mowrey accepted election as County Board Vice Chairman.

Chairman Schroeder discussed changes to the standing committees, which will take affect immediately. He said the Health Committee will no longer meet, with the sale of the Recycling Center; and Animal Control will report to the Tax Committee from this point on. The Policy & Procedure Committee will no longer meet on a regular basis, as their business is often redundant. Administrative Assistant Barb Witte will prepare the committee list and contact each member to advise them of the committees to which they will be assigned.

Chairman Schroeder said he is often asked about the feasability of conducting County Board meetings at night, which may allow more citizens to attend. He said the January, February, and March County Board meetings will be held at 7 PM, rather than 9 AM, on a trial basis.
