Chairman Schroeder called the meeting to order and asked County Clerk Lisa Fancher to call the roll.

Your Committee met at the Administrative Center on May 10, 2010 at 2:30 P.M. Members present Jim Meyer, Russell Bills, Kevin Hansen, Charles Alt, Harriett Mowrey, John Dowling, Susan Wynn Bence and Rod Copas. Also present County Board Chairman Ron Schroeder, Treasurer Mindy Kuntz Hagan, Sheriff Eldon Sprau, Supervisor of Assessments Bob Yergler, Circuit Clerk Lisa Hines, ESDA Director Carl Gerdovich, County Clerk Lisa Fancher, Probation Supervisor Barb King, Planning & Zoning Administrator Gloria Schleef, Data Processing Director Cecelia Dixon, County Information Systems Director Tom Tuntland, County Engineer Joel Moore, IDA Director Ken Barragree, Maintenance Supervisor Larry Pankey, Undersheriff Derek Hagen, Coroner Bill Cheatum, AFSCME President & County Highway Employee John Smith, Supervisor of Assessments employee Louise Bruens, Retired Sheriff Joe Mathy, County Board members Dennis Johnson, Jean Hiles, Bret Schmid, Dale Schultz, Jim McCray, Donna Wasmer, Kyle Anderson, Ernest Curtis, First Trust & Savings President Kerry Bell, Don Deany, Mike Moran and Kermit Wasmer.

The special Finance Committee meeting was called to order at 2:30 P.M.

First issue on the agenda for discussion was the financial situation of the County General Fund. Treasurer Mindy Kuntz Hagan reported the County received over the weekend a wire from the State in the amount of \$25,000, other State vouchers are on the Comptroller's desk but checks not released, there are \$74,000 of unpaid claims and the County has borrowed \$395,562 from the bank. The committee was concerned half of the claims are paid before going through committee for approval: utilities and health insurance claims etc, this had been mentioned in Clifton Gunderson LLP auditor's finding summary.

County Board Chairman Ron Schroeder said:

*County Board Chairman, Vice-Chairman and County Board members salaries by State Statutes is required to be set 180 days before taking office on December 6, 2010. This recommendation should come from this committee.

*Chairman Schroeder will asked County Coroner Bill Cheatum and Circuit Clerk Lisa Hines to voluntarily freeze their salary.

*Chief Judge Bradshaw said the County can establish furlough days for County employees, need to negotiate with the Union and notify them within 30 days. Judge Bradshaw also said County buildings could close on Fridays, except the Courthouse.

*Public would have to understand financially the County may no longer be able to provide some essential services five (5) days a week.

Sheriff Eldon Sprau said he had distributed handouts with information on financial and personnel issues facing the Sheriff's Office in April for the County Board to study and make a recommendation to close the jail. Kankakee County, who is in the same Judicial District, could house the prisoners for Iroquois County. This action would net a cost savings of \$200,000 annually. The maintenance and repairs to the building alone is 30% of the Sheriff's budget. Future expenses to consider if the jail remains open are: new locking system, replacement roof. The first appearance of an offender can be done by video from the Kankakee jail to the Iroquois County Courtroom saving on the transportation of prisoners. Sheriff Sprau asked for the committee's support and a recommendation to close the jail. One committee member suggested merging the Zoning & Planning Office into the Supervisor of Assessments Office and the Data Processing into the County Clerk's Office thus losing two employees rather than 9 employees and keeping the jail open.

Pros and cons of furlough days of County employees which could be an alternative to lay-offs was discussed. The pros and cons were discussed. It was moved by John Dowling and seconded by Russell Bills to have furlough days established for AFSCME and Probation employees taking off one (1) day a week for the remainder of the fiscal year, June 1st through November 30, 2010 with a proviso to send lay-off notices to all union employees. This would be a \$117,000 savings to the County. Roll call vote. Bills, aye; Hansen, aye; Alt, aye, Mowrey, aye; Dowling, aye; Wynn Bence, aye; Copas, aye; Meyer, aye. Motion carried.

It was moved by John Dowling and seconded by Harriett Mowrey to set May 18th, 2010 as the deadline for the Union to respond to the County's furlough day request. Motion carried.

The following paragraph was removed for separate consideration per action taken by the full County Board on May 11, 2010.

[It was moved by Kevin Hansen and seconded by Harriett Mowrey to recommend a vote from the County Board on the closing of the jail. Motion carried.]

The committee discussed setting the salaries of the County Board Chairman, Vice-Chairman and County Board members. It was moved by Russell Bills and seconded by Kevin Hansen to set the salary of County Board Chairman at \$400 per month, Vice-Chairman \$80 per month and County Board members per diem at \$25.00. Roll call vote. Bills, aye; Hansen, aye; Alt, aye; Mowrey, aye; Dowling, abstained; Wynn Bence, aye; Copas, nay; Meyer, aye. Motion carried.

Coroner Bill Cheatum and Circuit Clerk Lisa Hines graciously volunteered to freeze their salary. They will send a letter to the County Board confirming their decision.

The committee continued discussion of finances. President Kerry Bell told the committee First Trust & Savings Bank has signed a letter of commitment to the County to borrow up to \$1.5 million and will honor that commitment. Treasurer Mindy Kuntz Hagan reported the County will have funds for the May 21st \$200,000 payroll but not the June 4th before the next County Board meeting. It was moved by John Dowling to authorize Treasurer Mindy Kuntz Hagan to borrow up to \$400,000. Motion died for lack of a second.

The County Health Insurance will be negotiated during the Union contracts.

The remainder of the meeting was the discussion of a County long term financial plan to repay loans.

The following paragraph was removed for separate consideration per action taken by the full County Board on May 11, 2010.

Your Committee met at the Administrative Center on May 6, 2010 at 9:00 A.M. Also present County Board Chairman Ron Schroeder, Treasurer Mindy Kuntz Hagan, Sheriff Eldon Sprau, Supervisor of Assessments Bob Yergler, Circuit Clerk Lisa Hines, ESDA Director Carl Gerdovich, County Clerk Lisa Fancher, Probation Supervisor Barb King, Planning & Zoning Administrator Gloria Schleef, State's Attorney Jim Devine, Data Processing Director Cecelia Dixon, County Information Systems Director Tom Tuntland, County Board member Dale Schultz, Hope Wheeler partner, Sandy Cook CPA and Helen Barrick partner from Clifton Gunderson LLP, and Wendy Davis from the Times Republic.

The meeting was called to order.

Randy Schuldt from Schuldt Insurance was present and had no report. The committee discussed the pros and cons of Iroquois County and Ford-Iroquois Health Department having their own Workman's Comp polices. More research will be done.

Wade Bell from Bell Electric had concerns and questions on the \$47,500 originial bid specs for the Illinois Clean Energy Foundation lighting grant. The payment of the grant is based on the number of kilowatts of electricity demand reduced as a result of the project. Mr. Bell said

it was his understanding that additional work was done on the project without County Board approval. Iroquois County was awarded an \$86,400 grant based on information submitted.

Chairman Ron Schroeder was recognized by Chairman Jim Meyer and suggested the following points:

*Each committee has a responsibility to the Departments and Elected Officials that report to them and suggested they make decisions only on issues that pertain to their committee.

*Agrees with the Management Services Committee recommendation to sell the 37 acres of County owned timber. It is a non-performing asset. A specific project needs to be identified rather than to just put into the General Fund.

*Health Insurance Committee needs to meet soon to get a plan in place before the Union Negotiations take place in the fall.

*Finance Committee needs to set dates to begin the 2011 budget process. The County cannot negotiate until they have some solid figures.

The idea of hiring a County Manager was briefly discussed. Helen G. Barrick CPA and partner with Clifton Gunderson LLP said there are pros and cons to this position. It has worked for some Counties.

Hope Wheeler, partner in charge of the Iroquois County audit, introduced her colleagues, Sandy Cook and Helen Barrick, also a partner of Clifton Gunderson LLP. Ms. Wheeler presented the preliminary audit draft, which includes management discussion and analysis, basic financial statements, required supplemental information and other supplemental information. Ms. Wheeler highlighted several pages of the seventy-two (72)-page draft. She continued with a finding summary and answered questions:

*Financial statement preparation – general findings

*Adjusting entries –fifty-two (52) County and twenty-two (22) Health Department

- *Some due to rounding
- *Some adjust to accrual basis
- *Some adjust investments to confirmation
- *Negative cash borrowings
- *Prior period adjustment in Highway Fund
- *Invoices being paid prior to County Board approval
- *Approval for Election Judge Expenses not properly documented
- *Tracking collateral more closely
- *Interfund loans
- *Deficit fund balances General Fund \$30,000, Group Insurance \$400,000
- *No formal documentation of sample tax billing
- *Circuit Clerk lack of approval before checks are written
- *Grant expenses not tracked properly compared to grant income in grant fund
- *Segregation of duties
 - *Sheriff's Office
 - *Recorder
 - *County Clerk
- *Significant cash on hand in Treasurer's Office
- *Economic Interest Stmt not filed control process is needed to follow up
- *No review of property and equipment listing
- *IT recommendations

A five-minute recess was called at 10:30 A.M.

The meeting reconvened at 10:40 A.M.

The committee continued discussion of the County's financial situation. Suggestions made to solve some of the deficit were:

- *Negotiate with the Union for employees to take furlough days
- *Open 2010 budget
- *Hire County Manager
- *Ask the Union for concessions

The Finance Committee will post a Special Finance Meeting for May 10, 2010 at 2:30 P.M. The agenda will include:

- *Discuss salaries & benefits of all County employees
- *Recommend proposals to Unions
- *Discuss financial situation of General Fund

Data Processing Director Cecelia Dixon reported:

*The County has received the new IMRF rates. The deadline to notify IMRF of either the ARC or phase- in rate is August 31, 2010

*Explained how SB1946 will affect new hires after January 1, 2011. The changes included vesting from 8 to 10 years, retirement age 60 to 67, cap on earnings, among other changes. This will eventually impact the County's employer rate.

*Asked the committee if she should continue monitoring the General Ledger. It was the consensus of the committee to appoint Cecelia Dixon as the liaison to the auditor.

*Suggested early transfer of revenues from the General Fund to help with cash flow - \$40,000 from Farm Account, \$4,000 Revolving Loan Fund – Administration, \$25,000 from Circuit Clerk Automation, \$11,000 Child Support Fee, \$15,200 Probation Employee, \$5,000 County Highway and \$5,000 from Sale in Error.

County Treasurer Mindy Kuntz Hagan reported the amount borrowed from the bank is \$395,562. Payroll for May 7th is \$168,695, bills to be paid after the Tuesday, May 11th County Board meeting approximately \$200,000, currently have \$100,000 in bank, and the maximum line of credit per County Board action through May 11th is \$500,000. The General Fund still owes a \$100,000 inter-fund loan to the County Bridge Fund. The state owes the County \$600,000 to date.

Treasurer Hagan anticipates printing and mailing tax bills the middle of June with the first distribution in August.

Options to the financial situations resulted in committee members discussing bankruptcy, issuing 25 to 30 pink slips, sell the County Farm, etc.

Coroner Bill Cheatum said SB2559 has passed the House and Senate and is on the desk of the Governor to establish a special account in the County Treasury for the deposit of and an increase in the Coroner's fees. Currently, the fees are deposited into the General Fund of the County. Funds are to be used solely for the purchases of electronic and forensic identification equipment and the operating expenses of the Coroner's Office. Mr. Cheatum was at the Finance Committee meeting to request that a coroner's Automation Fund be created.

Coroner Cheatum also said the Coroner's Autopsy line item in his budget has \$2,000 remaining for the rest of the fiscal year. The County is mandated to fund this.

Sheriff Eldon Sprau said he was going to request a recommendation from this committee to either close the jail or not, but will wait until after the Monday, May 10^{th} Special Finance meeting.

Supervisor of Assessments Bob Yergler reported the tentative Board of Review assessment changes will be mail on Friday, May 7th and they will be in session again on May 17th for the final hearings.

County Clerk Lisa Fancher reported she had informed the Tax Committee about the \$3,800 HAVA grant that hasn't been used. An estimate has been obtained from Modern Glass, Watseka, IL to equip the north entrance doors at the Administrative Center for handicap accessibility due to the increased number of citizens who use the early voting privilege.

County Clerk Fancher said she is willing to transfer more from her two Automation Funds, County Clerk and Recording, each having \$20,000 available to transfer to the General Fund.

Planning and Zoning Administrator Gloria Schleef said the Vision Wind Tower project in Milks Grove Township is moving forward. The road agreements will be finalized in the near future.

IDA Director Ken Barragree explained the issue with the Illinois Clean Energy Foundation lighting grant. He is working with the DOC to subsidize the shortfall from the grant.

State's Attorney Jim Devine reported the County would be getting approximately \$40,000 from a drug fee case.

ESDA Director Carl Gerdovich said the final Mitigation meeting was held Wednesday, May 5th in the County Board room at the Administrative Center. The draft will be submitted to IEMA in Springfield, IL for review before the County Board can approve it.

It was moved by Kevin Hansen and seconded by Russell Bills to adjourn at 12:10 P.M. Motion carried.

Your Committee met at the Administrative Center on May 3, 2010 at 9:00 A.M. Members present were Harriett Mowrey, Beryle Luecke, Donna Wasmer, Jim McCray, John Dowling, Dennis Johnson, Jean Hiles, Adam Zumwalt and Kyle Anderson. Also present were County Board Chairman Ron Schroeder, Sheriff Eldon Sprau, IDA Director Ken Barragree, Maintenance Supervisor Larry Pankey, Mike Moran and Wendy Davis from the Times Republic.

The committee reviewed the claims. It was moved by Dennis Johnson and seconded by Donna Wasmer to pay the bills subject to County Board approval. Motion carried.

The Illinois Clean Energy Community Foundation lighting upgrade grant paperwork including the required documentation justifying all equipment/installation costs and the resulting savings was submitted for payment on April 19, 2010. The County has achieved the required wattage reduction of 172.80 kilowatts and the entire project an overall wattage reduction of 213.27 kilowatts with the additional lighting upgrades in the foyer of the Courthouse. IDA Director Ken Barragree has been in contact with Bob Romo from the Foundation who had requested a different format than submitted. With the help and cooperation of IDA Director Ken Barragree, Gordon Electric, Kankakee, IL and B & D Electric, Watseka, IL the proper format has been sent. The payment of the grant is based on the number of kilowatts of electricity demand reduced as a result of the project. The question remains whether the grant is based on usage demand or usage reduction. Mr. Barragree will contact Mr. Romo today, May 3, 2010 for verification.

The committee briefly discussed the model airplane flying field located on Courthouse road. Vehicles have been driving on the ground cutting tracks. Sheriff Eldon Sprau will investigate.

Kankakee Community College has given notice they will not automatically renew their rental contract with the County. Dean Dennis Sorensen has been contacted by County Board Vice Chairman Harriett Mowrey to work on an alternative arrangement. Due to severe State funding cuts, KCC will continue to lease Room 117, which has 803 square feet of classroom and terminate rental of Room 115A, which has 519 square feet of office space. KCC also utilizes the

Northeast Conference Room free of charge for college courses. After discussion, it was suggested that the County offer the office space of Room 115A free of charge for one year.

Sheriff Eldon Sprau reported the purchase of new scanner at the entrance of the Courthouse costing \$3,700 taken from the Court Security Fees fund. Sheriff Sprau said the maintenance and repair of the present scanner would cost more than a new scanner.

Maintenance Supervisor Larry Pankey reported:

- *There is a broken tile south of the Courthouse on the County Farm ground.
- *He will be checking with Schuldt Insurance about the Hartford Insurance fire inspection policy and report back to the committee.
- *Bennett & Brousseau has completed repairs on seams and cracks of the roof at the jail and Administrative Center.
- *Discussed Superior Elevator Inspections and Consulting fees for hydraulic elevators \$325 and dumbwaiter for \$125. The funds are available in the current budget, under Service Fees for Courthouse, Administrative Center & Jail.
- *Suggested the committee recommend to the full County Board to take advantage of a limited time offer to lock in the inspection for elevator and dumbwaiter fee at the current pricing level for the next 3 years. At the end of 3 years, the contract will automatically renew at a new rate based on the rates at the time of expiration. It was moved by Jean Hiles and seconded by Donna Wasmer to recommend to the full County Board to lock in the current inspection fee for the next 3 years. Motion carried.
- *Suggested the committee discuss the deterioriating steps on the east side of the Courthouse and what measures should be taken for repairs.

The remainder of the meeting was discussion of selling the 37 acres of County owned timber. Committee members suggested specifying where the money would go after the sale and sale to the highest bidder. Projects suggested were: roof at jail, painting of the Administrative Center, insulation at the Administrative Center, replace the roof at the County Highway Building, etc. It was moved by Jean Hiles and seconded by John Dowling to investigate selling the 37 acres of County owned timber. Any money realized from the sale would be used for specific projects but **not** go into the General Fund. Motion carried.

It was moved by Kyle Anderson and seconded by Adam Zumwalt to adjourn at 10:25 A.M. Motion carried.

Your Committee met at the Administrative Center on May 4, 2010 at 9:00 A.M. Members present were Dale Schultz, Troy Krumwiede, Dan Pursley, Betty Busick, Ernest Curtis and Merle Lemenager. Also present were County Board Chairman Ron Schroeder, County Board Vice Chairman Harriett Mowrey, Director of Data Processing Cecelia Dixon, Animal Control Administrator Dr. James Finnell, Treasurer Mindy Kuntz Hagan, County Clerk Lisa Fancher, County Information Systems Director Tom Tuntland, Chief Deputy from the Supervisor of Assessments Office Peggy Shouffler, County Highway Engineer Joel Moore, County Board member Jean Hiles, and Wendy Davis from the Times Republic.

The meeting was called to order.

The committee reviewed the claims. It was moved by Betty Busick and seconded by Ernest Curtis to pay the bills subject to County Board approval. Motion carried.

Animal Control Administrator Dr. James Finnell asked if the committee had any questions about the Animal Control claims.

Dr. Finnell reported:

- * A resident in Beaverville has been operating a cat rescue facility and intends to expand into dog rescue and adoption. The State inspector along with Animal Control Warden Dan Garner examined the facility and determined it was not adequate housing. The owner has been operating under a Foster Home License that allows each license holder to have four (4) dogs on the premise. Dr. Finnell said there a misunderstanding of a Kennel License the sole purpose is to limit the number of dogs.
- * At the April full County Board meeting the Poyner's petition to renew the Kennel License was not voted upon and returned to the Planning and Zoning committee for more information.
- * Animal Control Warden Dan Garner has located the owner of 17 dogs in Chebanse Township. None were vaccinated. The owner is not financially able to pay the vaccination cost and will relinquish the dogs to adoption.
- * Briefly discussed cat issues.

* Dr. Finnell said he has contacted State's Attorney Jim Devine to determine if Animal Control Warden Dan Garner and he can be declared a "Public Safety Officer" and be eligible for the Federal death benefit.

County Clerk Lisa Fancher reported:

- * Distributed copies of the monthly financial reports for the County Clerk and Recorder's Office.
- * Ms. Fancher has been communicating with State's Attorney Jim Devine about required agendas for the board's monthly meetings. The current agenda fails to outline the specific actions the board expects to take, which is an apparent violation of the Illinois Open Meetings Act. The Paxton Record has filed a request for review, with the Illinois Attorney General's Office asking for a public access counselor to investigate the complaint. A new format designed in the County Clerk's Office was distributed to the committee to review for possible use.
- * The unused \$3,800 grant issued to the County Clerk's Office in 2006 for handicap accessible voting facilities was discussed. An estimate from Modern Glass, Watseka, IL has been obtained to make both doors at the north entrance at the Administrative Center handicap accessible.
- * Briefly discussed combining two or more voting precincts into "voting centers".
- * Asked the committee's opinion on renting a booth at the Iroquois County Fair. The cost is \$175 and is manned by County Clerk personnel. It was the consensus of the committee to continue renting space especially for the public opinion poll.
- * The County Clerk's Office has been visiting county schools registering 18 year olds to vote.
- * The Iroquois County Trustee has completed paperwork to move money, which has been collected through the delinquent tax process, from the County Clerk's account to the County Redemption Fund.

County Treasurer Mindy Kuntz Hagan reported:

- * The deadline to pay Mobile Home Taxes is Friday, May 7, 2010.
- * Real Estate Tax bills will be mailed mid to late June.
- * She will request a copy of the implementation plan for Iroquois County from DEVNET. Joedy Smith from DEVNET was unable to attend today.

Chief Deputy Peggy Shouffler from the Supervisor of Assessments Office reported the tentative assessment changes will be mailed on Friday, May 7, 2010. The Board of Review will be in session May 17 through 21, 2010 to hear final complaints. Complaints are up as taxpayers feel they are over assessed based on the economy.

County Board Chairman Ron Schroeder asked the feeling of the committee to put the Public Safety Tax back on the ballot in the November election. The committee discussed asking for ¼ cent to cover Sheriff's department shortfall. The ¼ cent would result in no excess funding but if the schools were going to ask the taxpayers for a 1 cent tax, the County should back off. A letter to the Superintendents of Schools was discussed. It was suggested a telephone call by Administrative Assistant Barb Witte to each school was appropriate to get a census of what direction they are taking.

It was moved by Merle Lemenager and seconded by Dan Pursley to adjourn at 10:35 A.M. Motion carried.

Your Committee met at the Courthouse on May 5, 2010 at 9:00 A.M. Members present were Susan Wynn Bence, Donna Crow, Rod Copas, Bret Schmid, Kyle Anderson and Betty Busick. Also present County Board Chairman Ron Schroeder, County Board Vice Chairman Harriett Mowrey, Sheriff Eldon Sprau, Coroner Bill Cheatum, State's Attorney Jim Devine, ESDA Director Carl Gerdovich, County Board member Jean Hiles and Wendy Davis from the Times Republic.

The meeting was called to order at 9:00 A.M.

According to the agenda under New Business there was discussion of the Public Safety Tax being put back on the November ballot. The committee briefly debated the pros and cons; specifically the County Board needs a plan how to spend the funds.

Committee Chairman Susan Wynn Bence read the report from Probation Supervisor Barb King who was attending a Juvenille Law conference in Bloomington, IL. The report was as follows:

*Ms. King has checked about the insurance on the ankle bracelet units rented from Secure Alert. The original contract did not include insurance, so there has not been insurance on the devices. The cost is still .35 per day per unit (this applies to shelf units as well). Only a few units have been lost or tampered. The committee felt the cost of the insurance would outweigh the County replacing them on their own.

*Verizon has been contacted concerning a late charge on her cell phone. The fee will be waived one time. The billing cycle has been changed so the due date is 5 days later which should cover the time lapse between board meeting and check issue and receipt.

Coroner Bill Cheatum reported he has only \$2,000 left out of the \$17,000 budgeted Autopsy line item due to eleven (11) autopsies already this fiscal year. The County typically pays the Kankakee Pathologist \$250 morgue fee, \$180 toxicology fee and \$925 for the autopsy mandated by the State Statutes.

Coroner Cheatum said there is SB2529, which was passed by both the House and Senate, on the Governor's desk that will change the amount of a cremation fee from \$10 to \$50. This bill establishes a special account in the County Treasury for the deposit of the Coroner's fees which are currently deposited into the general fund of the County. The funds in the special account could be used solely for the purchase of electronic and forensic identification equipment and the operating expenses of the Coroner's Office. Coroner Cheatum will attend the Finance Committee on May 6, 2010 to request that a Coroner Automation Fund be created.

ESDA Director Carl Gerdovich invited the committee members to the Mitigation Plan review today, May 5, 2010, from 6 p.m. to 9 p.m. in the County Board Room at the Administrative Center. Mr. Gerdovich said for future information and consideration Iroquois County ESDA has access to GIS (Geographic Information System) that was acquired through a grant from the Illinois Terrorism Task Force. The equipment is in-hand, needs to be set up and local personnel needs to be trained. The opportunity is there for networking for use by other Iroquois County departments. ESDA is open to all discussions with other County Offices.

Sheriff Eldon Sprau reported a new scanner at the entrance of the Courthouse has been purchased from O'Herron Police Supply, Danville, IL. It was listed for \$4500 and was purchased for \$3700 from the Court Security Fee fund. Sheriff Sprau wanted the Judicial & Public Safety Committee to be aware that more overtime during the summer months for Correction Officers would be submitted. He also noted that the gas line item will be over by August or September of this year.

Sheriff Sprau said he will be going the Finance Committee asking for their recommendation to either close the jail or not.

The following paragraph was removed for separate consideration per action by the full County Board on May 11, 2010.

[The committee continued discussion on the Public Safety Tax. It was the general consensus of the committee that if a Public Safety Tax is back on the November ballot there needs to be long term plan for specific projects and to get a new sales tax projection from the Department of Revenue. It was moved by Donna Crow and seconded by Betty Busick to recommend the Public Safety Tax be put back on the November ballot at ½ cent per the statuary wording. Roll call vote. Schmid, aye; Anderson, aye; Busick, aye; Crow, aye; Copas, nay; Wynn Bence, aye. Motion carried.]

Judge Gordon Lustfeldt updated the committee on the bailiff IMRF appeal and discussed other court hearing decisions.

Also present were Zoning Administrator Gloria Schleef and Assistant Zoning Administrator Debbie Wright. Don Wauthier, Pat Murphy, Christina Poyner, Derek Poyner, Mike Moran, Gerald Nakaerts, Dr. James Finnell, State's Attorney Jim Devine, and Wendy Davis from the Times Republic were also in attendance.

Ms. Schleef said Regional Planning Commission had been held last Tuesday night. Joe Yobbka had come with a house request on his Planned Unit Development. When he was approved in 2006, any change to the Planned Unit Development would require approval from the County Board. There were several neighbors in attendance and lots of dialogue. Mr. Yobbka also has three travel trailers on his property, which have been on the property for over a year. Mr. Yobbka has been asked to move the travel trailers. The Ordinance states travel trailers must be moved after 180 days. The Ordinance does not state how long they must be removed. There was discussion regarding time limits but no action was taken.

Mr. Pursley made a motion to re-appoint Charles Leitz to the Regional Planning Commission. Donna Crow seconded this motion. This motion was approved by voice vote.

Mr. Schultz was asked to read a letter from Merle Lemenager who was unable to attend the Planning & Zoning Committee meeting due to a hip replacement. This letter states some problem kennels the County has had in the past. This letter is attached.

Mr. Devine passed out the written penalties for offenses, which was approved at County Board in April. These changes will have to go through public hearing.

There was general discussion on the number of dogs allowed with the Kennel Ordinance.

Mr. Schultz made a motion to incorporate in the Kennel Ordinance not more than four dogs were to be in the house. Mr. Devine will write this up. Mr. Meyer seconded this motion. This motion was approved by voice vote.

Mr. Schultz made a motion to approve the claims for future payment by the full County Board. Mr. Pursley seconded this motion. This motion was approved by voice vote.

A public hearing was held for Christina Poyner represented by Pat Murphy. Mr. Murphy said they had been redirected back to this Committee from the County Board last month. He said all the female dogs have been neutered and all dogs have been registered with the County. Ms. Poyner has surrendered her existing Kennel Licenses and Foster License from the State. Ms. Poyner stated Ms. Schleef had written up a letter for her to sign regarding her reapplying for these licenses. Mr. Murphy said Ms. Poyner is requesting a regular Kennel for her pets.

After much discussion, Mr. Pursley made a motion to **approve** this Kennel request. This motion died for lack of a second. This request will be sent to County Board. An approval of two-thirds majority will be required because Chebanse Township Planning has denied this request.

As there was no further business to come before the Committee, Mr. Schultz made a motion, seconded by Mr. Luecke to adjourn the meeting at 10:25 A.M.

I am not able to attend the Planning and Zoning Committee Meeting because I will have hip surgery May 6^{th} and will be in the hospital. However, I would like to give you some of my thoughts regarding the kennel request. Not all Members of the Committee or the Board have served during some of the previous kennel requests. I would like to remind the Members of some of our previous problem kennels.

Elizabeth Brown sued the County for three million dollars. She did lose but there were several court appearances. She began the conditional use process for a kennel with twenty dogs and the number of dogs had doubled the next year. She trashed the house with cats. She had numerous cats in the house with small children. The taxes have not been paid and if the County ends up with the house, it will cost approximately \$20,000 to tear it down and haul it away.

Jean Fleming obtained a building permit for a shed. The building inspector found many dogs while he was doing the construction inspection. The little dogs were in a 5' x 6' trailer without air conditioning. The larger dogs were to be put into the shed.

An onsite inspection was done of the property. There were approximately one hundred and twenty dogs at the location. Crates with dogs were piled on top of each other. The dogs were used for breeding.

Barbara Hammill started the conditional use process for a kennel. She did not complete the process. She was going to sue the County but needed to finish the conditional process first.

Animal Control obtained a search warrant. An in home inspection revealed dogs, numerous cats, three pot-bellied pigs, twelve parrots, a wolf-dog mix, etc. all living in the house. The house was in deplorable condition. The carpeting was saturated with urine and the tiles and flooring was all torn up.

I mention all the previous problems we have had with kennels to remind the Members the difficulty we have had with some of our kennels. We also have had some very good kennels. But we need to determine the type of kennel and how the dogs will be treated and taken care of.
