PUBLIC COMMENTS

911 Director and I-COM Director Nita Dubble told the Board that a Proclamation has been signed by Iroquois County Board Chairman Ronald Schroeder recognizing the week of April 10-16 as National Telecommunicator Week. Nita also told the Board that she will be going to Springfield to talk to legislators about the financial problems that 911 is facing due to people dropping their land line phones. She asked for the full Board support in a letter drafted to the legislators that represent Iroquois County showing the need for their support in getting legislation approved to ensure funding for 911.

There were various citizens that were present to speak about the wind farms both positively and negatively. Attorney Brent Holmes presented a letter on behalf of his clients, John & Rita Shure. He spoke of the need for a stronger wind ordinance, with larger setbacks and higher decommissioning costs. Kelly Kepner, with Benton County, Indiana, Economic Development said the wind farms that are located in her county have provided better roads, better schools, and enhanced fire departments, not to mention expanding businesses. She said the wind ordinance needs to be reasonable and cannot demand too much without deterring the wind farms.

COUNTY ENGINEER JOEL MOORE

County Engineer Joel Moore asked to be on the agenda to address the Board first hand regarding three specific items. The first issue is the \$223,546 that was received from a Road Use Agreement with the Sheldon wind farm. He said there would be 25-30 year wear on the roads in just a few months and he wanted to make sure those roads were repaired at no cost to the tax payers. This money is to ensure that any engineering fees or costs are covered should the Highway Department need to hire a consultant due to lack of employees.

Joel also discussed the missing cash box at the Highway Department. He explained that there was an ongoing investigation and that was the reason behind the lack of communication. At the present time there have been no leads, there will be no more petty cash at the Highway Department, and all locks will be replaced at the Highway Department to ensure the proper people have keys and access to the property.

Joel also talked about his salary. In 2006, when Joel was hired, he was willing to start below the IDOT recommended rate. Due to the financial situation of the County, for the past four years, he hasn't taken the full raise that by contract he could insist.

Your Committee met at the Administrative Center on April 5, 2011 at 12:00 P.M. Members present were County Board Chairman Ron Schroeder, Russell Bills, Jim Meyer and Dale Schultz. Also present Vice Chairman John Wilkening, 911 Coordinator Nita Dubble,

Treasurer Mindy Kuntz Hagan, Planning & Zoning Administrator Gloria Schleef, Data Processing Director Cecelia Dixon, County Clerk & Recorder Lisa Fancher, Supervisor of Assessments Bob Yergler, County Information Systems Director Tom Tuntland, and Wendy Davis from the Times Republic.

911 Coordinator Nita Dubble said the Intergovernmental Agreement providing for Joint Dispatch Services consists of the City of Watseka, Emergency Telephone System Board, and Iroquois County to pay the necessary operating costs of nine (9) dispatchers. Ms. Dubble was asking the County Board to continue funding the agency \$143,666 a year as does the City of Watseka and the ETSB Board. The reduction of revenue of 5,000 landline telephones puts a burden on the funds to replace the 911 equipment. If new equipment is not purchased, they will be unable to continue beyond the 2012-2013 budget. It was moved by John Wilkening and seconded by Dale Schultz to recommend the County maintain funding at the present level as long as the City of Watseka follows suit. Roll Call vote. Bills, aye; Meyer, aye; Wilkening, aye; Schultz, aye; Schroeder, aye. Motion carried unanimously.

The County Liquor License fees were discussed. There are ten (10) establishments in the County – four 1 A.M. at \$700 each, two 2 A.M., at \$950, four club licenses at \$450. It was moved by John Wilkening to increase fees across the board by \$50. The motion died for a lack of a second.

Gregg Murphy representing I-KAN asked the committee to support a Resolution that would not eliminate funding for I-KAN. The State has announced major budget cuts in the education sector including elimination of the State's forty-four Regional Superintendents of Schools offices. The offices oversee programs ranging from fingerprinting school bus drivers to student truancy. The Resolution would be sent to all State Legislators if approved by the County Board. It was moved by John Wilkening and seconded by Dale Schultz to support the Resolution. Roll Call vote. Bills, aye; Meyer, aye; Wilkening, aye; Schultz, aye; Schroeder, aye. Motion carried.

The resignation of the Data Processing Director Cecelia Dixon was discussed. The consensus of the committee was to advertise in the Kankakee Journal, Times Republic, Champaign News Gazette, and the County web site. All resumes will be sent to County Board Chairman Ron Schroeder. Deadline is May 2, 2011. The Policy & Procedure Committee will review and make a recommendation to fill the position. It was moved by John Wilkening and seconded by Jim Meyer to proceed with the advertising. Motion carried. Roll Call vote. Bills, aye; Meyer, aye; Wilkening, aye; Schultz, nay; Schroeder, aye. Motion carried.

The committee discussed how to handle follow-up issues that were discussed in regular committee meetings and fall through the cracks. RESOLUTION NO. R2011-3

WHEREAS, the Governor of the State of Illinois has recommended to the Illinois General Assembly that the state's financial standings is in peril requiring the implementation of strategic initiatives; and,

WHEREAS, among the strategic initiatives recommended by the Governor of the State of Illinois includes the elimination of funding for the state's Regional Offices of Education; and,

WHEREAS, the state's Regional Offices of Education have provided the education community with required professional development for improved learning for the children of Illinois; and,

WHEREAS, the state's Regional Offices of Education have conducted comprehensive operational reviews of schools and school districts ensuring compliance with the Illinois School Code and attendant rules and regulations in a high quality manner; and,

WHEREAS, the state's Regional Office of Education have provided such valuable assistance in attaining grants and alternative sources of revenue to augment learning for the children of Illinois and ease the tax burden for the citizens of Illinois; and,

WHEREAS, the state's Regional Offices of Education have taken the leadership for the dissemination and implementation of Illinois State Board of Education Policies, Rules and Regulations; and,

WHEREAS, the state's Regional Office of Education have remained at the forefront of the implementation of instruction aligned to the Illinois Learning Standards; and,

WHEREAS, the state's Regional Offices of Education have provided outstanding service for teachers seeking to gain and renew certification for employment; and,

WHEREAS, the state's Regional Offices of Education have provided high quality, direct services to students through Truancy Prevention, alternative educational environments for students who would otherwise be expelled and educational programs for potential dropouts; and,

NOW, THEREFORE BE IT AND IT IS HEREBY RESOLVED that the County Board of Iroquois County, Illinois, that:

- **Section 1.** The state's Regional Offices of Education funding should not be eliminated.
- **Section 2.** The governor of the State of Illinois should not recommend elimination of said funding for Regional Offices of Education.
- **Section 3.** The Illinois General Assembly should not approve the elimination of said funding for Regional Offices of Education.
- **Section 4.** The County Board Chairman shall send a copy of this resolution to all state legislators serving the residents of Iroquois County.
- **Section 5.** This Resolution shall be in full force and effect immediately upon its passage.

Your Committee met at the Administrative Center on April 4, 2011 at 2:00 P.M. Members present were Ron Schroeder, District I; Jim Meyer, District I; John Wilkening, District V; Jed Whitlow, District IV; Kyle Anderson, District II; Dale Schultz, District I and Rod Copas, District IV. Also present County Clerk & Recorder Lisa Fancher and Wendy Davis from the Times Republic.

The meeting was called to order.

County Board Chairman Ron Schroeder announced the Redistricting meeting scheduled for April 5, 2011 at 10:30 A.M. will be cancelled and the time for the for April 7th, 2011 will be changed to noon.

The purpose of the redistricting meeting is to discuss and determine if the size of the County Board should be reduced. Public perception is the members of the board receive health insurance, retirement, and other benefits based on information they heard about other Counties in the State and would prefer a smaller County Board. The board costs the taxpayer about \$40,124 in FY 2010. The per diem of a County Board member is \$25 and mileage is 51 cents per mile. The County Board Chairman appoints members to eleven other committees including Iroquois Memorial Hospital Board, Champaign Consortium, Old Courthouse Museum, East Central Illinois Community Action, Liquor Commissioner, Regional Planning, 911 Board, Route 1 Association, Iroquois Industrial Development Association, I-KAN, and 708 Board. It was the consensus of the committee the County Board does not promote itself well enough through media coverage. Currently, there is no representation in the smaller townships – Milks Grove, Danforth, Artesia, Ridgeland, Onarga, Prairie Green, Milford, Stockland, Fountain Creek, Beaver or Beaverville. The number of registered voters is not there to elect a representative. According to the Illinois Compiled Statutes, if the County Board determines that members shall be elected by districts, it shall develop an apportionment plan and specify the number of districts and the number of County board members to be elected from each district. Each district:

*Shall be equal in population to all other districts.

*Shall be comprised of contiguous territory, as nearly compact as practicable.

*May divide township or municipalities only when necessary to conform to the population requirement.

*Shall be created so that no precinct shall be divided between 2 or more districts. A reapportionment plan must be prepared by July 1, 2011.

There was a brief discussion of the Iroquois County Emergency System Agreement between the City of Watseka, 911 Board, and Iroquois County and their fiscal responsibilities.

Other issues discussed were:

- *Prepare a press release
- *Prepare a fact sheet
- *Should the Board Chairman be elected at large

Dale Schultz, District I, presented eight different scenarios of county district maps targeting population and percent difference for the committee to review. The committee narrowed the maps down to three with percents ranging from 2.10% to 3.7%. The committee will review maps and continue discussion on April 6, 2011 at 1:30 P.M.

It was moved by Dale Schultz and seconded by Rod Copas to adjourn at 3:40 P.M. Motion carried.

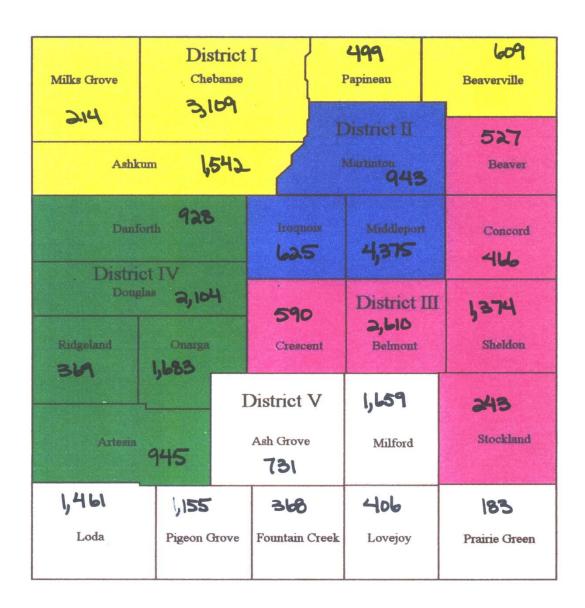

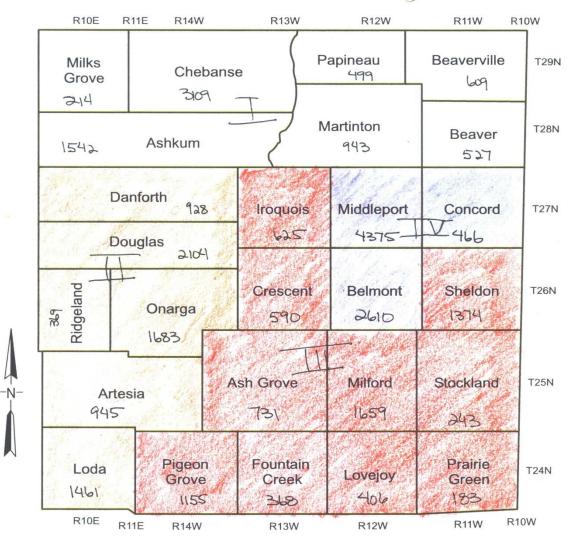

Your Committee met at the Administrative Center on April 7, 2011 at 9:00 A.M. Members present were Jim Meyer, Russell Bills, Don Deany, Charles Alt, Kevin Hansen, Dave Hubert, Kyle Anderson, Susan Wynn Bence and Rod Copas. Also present Data Processing Director Cecelia Dixon, Probation Director Carl Brown, Probation Supervisor Barb King, County Clerk & Recorder Lisa Fancher, Supervisor of Assessments Bob Yergler, Nita Dubble 911 Coordinator, County Information Systems Director Tom Tuntland, Treasurer Mindy Kuntz Hagan, Ford-Iroquois Extension Director Karen Moore, County Board members Dale Schultz and Jean Hiles, ESDA Director Carl Gerdovich, Mike Moran, and Wendy Davis from the Times Republic.

The meeting was called to order.

Nita Dubble, 911 Coordinator told the committee she has made a presentation at the Tax Committee and Judicial Public Safety Committee meetings explaining the difference between Iroquois County Emergency Telephone System Board (ETSB) and Iroquois County Joint Dispatch which are two separate entities. A handout was distributed to the committee. In 2000 the City of Watseka, Iroquois County Board, and ETSB signed an agreement to form ICOM. As per agreement the ICOM budget is to be divided equally by the three entities. Each entity pays \$143,667. During the County's budget hearings, the ICOM budget was reduced by 5% but a letter of notification per agreement was not sent to ICOM. A letter will be composed and sent to ICOM to comply with 180 day notification of any change in their budget. After discussion, it was moved by Rod Copas and seconded by Kyle Anderson to continue funding ICOM at the current \$143,677 as long as the City of Watseka continues their funding at the same amount. Roll Call vote. Bills, aye; Deany, aye; Alt, aye; Hansen, aye; Anderson, aye; Hubert, aye; Wynn Bence, aye; Copas, aye; Meyer, aye. Motion carried.

County Extension Director Karen Moore was introduced and gave the annual report of the Ford-Iroquois Extension Office. Ms. Moore also pointed out the new logo featured on the annual report which is a reminder that the mission of the University of Illinois Extension is to provide high-impact programs that help make life better, healthier, safer, and more prosperous by "Investing in YOU". Ford-Iroquois Unit will be sharing staff and resources with Champaign and Vermilion Counties as one of the 27 new multi-county units. Their budget has a different fiscal year than the County's. It is from July 1st rather than the County's December 1st fiscal year. Funding sources include local taxes from Ford and Iroquois County, donations from individuals/organizations. State matching based on local support, Federal grants, etc. Ms Moore told the committee the requested amount from the County will remain at \$101,300.00 (0.02292 rate/\$100 EAV) \$3.41 per capita based on 2010 Iroquois County census figures of 29,690. It was moved by Russell Bills and seconded by Rod Copas to recommend the requested funding for 2012 year. Roll Call vote. Bills, aye; Deany, aye; Alt, aye; Hansen, aye; Anderson, aye; Hubert, aye; Wynn Bence, present; Copas, aye; Meyer, present. Motion carried.

The County auditors from Clifton Gunderson, LLP, Hope Wheeler, Partner and Sandy Cook, Senior Manager, presented the preliminary draft of the County's audit ending fiscal year November 30, 2010. Ms. Wheeler said their audit was performed for the purpose of forming and expressing an opinion about whether the financial statement, prepared by management with the County's oversight is presented fairly in all material respect and conformity with generally accepted accounting principles. The past year the County struggled with increasing expenses and decreasing revenues. The State of Illinois has not been timely with reimbursement payments for the State's Attorney, Public Defender, Probation and Supervisor of Assessments. Budget cuts were made with union employees each taking at least 10 furlough days. Non-union employees were asked to pay \$200 per month towards health insurance. The County had to borrow from the local banks; a public safety tax did not pass and resulted in several layoffs to the Sheriff's department. At the end of the fiscal year the overall financial position has slightly improved partly due to one- time revenue from the wind turbine permit fees. One issue brought to the attention of the Finance Committee that was found during the audit process was that the County Treasurer's Office had accumulated a large amount of cash on hand. Ms. Wheeler said there is a greater potential for misappropriation of cash when large amounts of cash are on hand and not deposited in the bank and the opportunity to earn interest is lost. She recommended a minimum amount of cash be kept on hand to accommodate the daily functions of the office and deposits

should be made frequently. She discussed briefly the increased proficiency the County will realize with a new accounting system.

Probation Director Carl Brown asked the committee to approve a line item transfer to cover an expense of \$1,813 for tuition of a probation officer as agreed upon in the Probation contract. Mr. Brown discussed hiring and sharing a part-time Administrative Assistant. It was moved by Rod Copas and seconded by Charles Alt to approve the line transfers. Motion carried. No decision was recommended on hiring which not on the agenda.

Treasurer Mindy Kuntz Hagan said two Solid Waste CDs will come due April 10, 2011. They are currently 6 month CDs each earning .90%. There is one \$50,000 and a \$100,000 CD. It was the consensus of the committee to let them roll over. Ms. Hagan received a fax of a copy of a letter from Governor Quinn to the Comptroller authorizing the additional appropriations for the reimbursement of the State's Attorney and Public Defenders salaries until June 30, 2011. Treasurer Hagan said a company from California has bombarded Treasurers statewide for free copies of all our real estate tax files. According to the Freedom of Information Act, a fee will be charged for requested information. The County has the information available on a CD at a cost of \$750.00.

County Clerk & Recorder Lisa Fancher said her office staff has contacted River Valley Recycling asking how to dispose of antiquated County electronics. The County Clerk will schedule a pickup date.

Supervisor of Assessments Bob Yergler said paperwork has been turned over to the County Clerk's Office to begin the tax extension process, and the final abstracts have been forwarded to Department of Revenue in Springfield, IL.

The committee reviewed the claims. It was moved by Russell Bills and seconded by Dave Hubert to pay the bills subject to County Board approval. Roll call vote. Bills, aye; Deany, aye; Alt, aye; Hansen, aye: Anderson, aye; Hubert, aye; Wynn Bence, abstain; Copas, nay; Meyer, aye. Motion carried.

Discussion of General Fund classifications followed directed to the Treasurer. The County Board has set no boundaries.

It was moved by Russell Bills and seconded by Don Deany to go into Executive Session at 12:13 p.m. to discuss personnel and negotiations. Motion carried.

It was moved by Russell Bills and seconded by Susan Wynn Bence to go out of Executive Session at 12:50 P.M. Motion carried.

It was the consensus of the committee to include on the May Finance Committee agenda looking into hiring a consultant to do a feasibility study on closing the Iroquois County Jail.

911 Coordinator Nita Dubble distributed a handout to the committee explaining the difference between Iroquois County Emergency Telephone System Board (ETSB) and Iroquois County Joint Dispatch (ICOM) which are two separate entities. In 1994 the voters of Iroquois County at the general election approved a surcharge of \$2.00 per month for 911. The ETSB's only funding is from the \$1.94 of the \$2.00 fee collected from landlines which can only be increased by another public vote. ETSB receives.5625 of the 73 cents paid per cell phone and this amount can only be changed by legislation. ETSB received \$25,000 a month from landlines

and \$11,500 a month from cell phones. If ETSB no longer has money to operate, the 911 system will become the responsibility of the Iroquois County Board. In 2000 the City of Watseka, Iroquois County Board, and ETSB signed an agreement to form ICOM. As per agreement the ICOM budget is to be divided equally by the three entities. Each entity pays \$143,667. The County notified the ICOM board verbally and in writing by the City of Watseka they can no longer pay the total amount needed. ICOM needs in writing a 180 day notice of a budget change. The ICOM board is requesting all three entities continue to pay their share until additional funding can be found. If funding cannot be found ICOM will fold and the dispatching service will become the responsibility of the Iroquois County Board for county services and each fire, police and EMS will be in charge of providing their own. It was moved by Jean Hiles and seconded by Jed Whitlow to continue funding ICOM until other revenues are found as long as the City of Watseka continues their funding at the current \$143,667. Coroner Bill Cheatum reported on an indigent case where no family member wants to take responsibility for the deceased funeral expenses. The \$275 expense will be taken from the Coroner Automation if no revenue is found.

Probation Supervisor Barb King said the office has purchased three (3) new monitors for \$90 each. The two fax machines are not working but have borrowed one from Kankakee County.

Circuit Clerk Lisa Hines said she is distributing a list of claims that was paid out of the Child Support Account. Traffic fines are \$28,000 for March.

Sheriff Derek Hagen was not present and sent his report which included:

Your Committee met at the Administrative Center on April 8, 2011 at 9:00 A.M. Members present were Donna Wasmer, Don Deany, Jim Meyer, Dale Schultz, Adam Zumwalt, Troy Krumwiede, Merle Lemenager, Dan Pursley, and Keith McTaggart. Also present were Zoning Administrator Gloria Schleef and Assistant Zoning Administrator Debbie Wright. Also in attendance were Jean Hiles, Earl Dixon, Marvin Stichnoth, Rita Shure, Dan Houmes, Richard Swartz, Bill Langellier, Roger Gustafson, Glen Boehrnsen, Cindy Boehrnsen, Lou Graham, Dale Graham, Theta Lee, Richard Ziebart, Chuck Garfield, Kim Schertz, Delmar Graham, Kermit Wasmer, Harriett Mowrey, and Wendy Davis from the Times Republic.

Ms. Wasmer announced that there would be public comments before the Wind Ordinance Revisions hearing. There would be a limit of fifteen minutes for pro-towers and fifteen minutes for against the towers. The Zoning Board of Appeals public hearing was held March 29, 2011 which started at 7:30 p.m. and ended at 12:30 a.m. The sign in sheet from that meeting was taken and it needs to be returned to the Zoning Office. The Zoning Board of Appeals approved all the proposed changes except for the decommissioning. They felt the \$10,000.00 for the decommissioning was not enough but had not given a number.

The Committee reviewed the decommissioning portion of the Champaign County Zoning Ordinance. No action was taken.

Mr. Pursley made a motion to extend the moratorium until the next County Board of May 10, 2011. Mr. Zumwalt seconded the motion.

A roll call was conducted. The motion was approved with Keith McTaggart voting "nay".

Mr. Meyer made a motion, which was seconded by Mr. Schultz to approve the claims.

A roll call was conducted. The claims were approved with Troy Krumwiede voting "nav".

Ms. Schleef said she didn't have time to review the Flood Plain Ordinance. There is already a Zoning Board of Appeals hearing scheduled for April 26, 2011.

A County Board member came in and said a builder asked about the square footage for the RH-1, Rural Homestead. He felt smaller than 1,850 square feet would be better. No action was taken.

Ms. Wasmer said the first hearing would be for Glen and Cindy Boehrnsen from Martinton Township. They are requesting a kennel for ten to fourteen dogs. Glen and Cindy Boehrnsen came forward. Mr. Boehrnsen stated they would like to expand their breeding and show dogs. They have been doing this for the last four years. They have been limited to the number of dogs they could keep out of their own breeding stock. They will remodel their existing facility and add a lean-to. They do not want to board dogs. They have Watseka Animal Hospital do all of the shots. They do sell the puppies. Dr. Finnell and Dan Garner were to the property and did like what they have.

Mr. Krumwiede made a motion to approve this kennel request. Mr. Zumwalt seconded the motion.

A roll call was conducted. It was unanimous to approve this request.

The next hearing is for the Wind Tower Ordinance Revisions. First will be public comments with a limit of fifteen minutes speaking for the towers and fifteen minutes speaking against the towers.

Kim Schertz from Hudson, IL came forward. She spoke highly against the County using the Champaign County Ordinance for the decommissioning. She spoke on what some other counties are doing regarding the decommissioning. She believes there could be a problem with the schools receiving more money after the first couple of years.

Rita Shure from Artesia Township came forward. Ms. Shure said she is concerned about safety. Her husband and she have been in the cooling tower business for thirty-five years. They are familiar with drive shafts. Seals break. The gearboxes will not last the number of years being stated they will. There are fire hazards. She does not believe the 1,500' is far enough away. The short-term profit needs to be evaluated in terms of long-term effects.

Richard Swartz from Prairie Green Township came forward. There has been so much negative regarding the wind towers he would like to give a good news report. There have been well-written good articles from the Times paper regarding the county's financial situation. In 2010, there was \$129,000.00 taken in windmill building permit fees along with a flood reimbursement and drug money. The County will continue to have wind tower building permit money coming in. The \$129,000.00 was 250% higher than the flood reimbursement and the drug money. He said he also wanted to clear up a misconception about their group. They work with the wind developer and do not solicit people to sign up for wind towers. He believes an Ordinance should be received from a county that has a successful wind farm. Champaign does not have one. There are a lot of counties in Illinois that are successful. As far as hazards to health, living is hazardous to health.

Theta Lee came forward and stated she would talk in favor of wind farms. She said a moratorium was extended in order to further review Champaign's decommissioning. This might not send a favorable message for wind farms in the County. McLean County has over 1,900 megawatts permitted with no wind ordinance. They have a presentation from the wind farm with hearings. She thinks the County should let the landowner and the wind farm do their plan. Dale Hastings should be contacted to explain the formula for the schools. There was a very good article in the Kankakee paper stating Settlers Trail will generate much more than electricity. Richard Ressler, a retired farm auctioneer, criticized the County for tightening the Wind Ordinance. He urges them to carefully consider this and welcome these companies.

Richard Ziebart from Prairie Green Township said when farmers have money they spend it and the farmers usually spend their money locally. There are a lot of other benefits to local businesses.

Jim Meyer came forward and stated everyone thinks he is against the wind farms. Mr. Meyer said he is the County's Finance Chairman. The auditor commended Iroquois County for making tremendous efforts in fixing their financial difficulties. The ending balance for 2010 was \$140,000.00 compared with the FY09 of -\$600,000.00. He said all he wanted was a little consideration for the non-participant who is reaping no benefits.

Ms. Wasmer said the Wind Ordinance revisions will be reviewed item by item. The Zoning Board of Appeals had approved all the revisions except for the decommissioning. Ms. Schleef said the revisions had been reviewed at the Zoning Board of Appeals page by page. They could be voted on separately or by groups. On page four "churches and schools" were added as primary structures. Under the siting approval, "this application must be submitted in English." The next change is on page six. This has been changed several times. The initial fee to start the rezoning process was \$1,500.00 with the applicant paying \$750.00 for each Zoning Board of Appeals hearing, the publication costs, and the court stenographer. The application fee

will be changed to "\$50,000.00 and all expenses will be paid by the County. If the expenses exceed \$50,000.00 the applicant will pay the additional fees in a timely manner."

Mr. Schultz made a motion to approve the above read changes. Mr. Deany seconded the motion.

A roll call was conducted. These changes were approved unanimously.

Ms. Schleef said the next is on page seven under electrical components. "All electrical wire and lines connecting WECS to another WECS or substation must be installed no less than four feet deep. The owner/operator of the WECS Installation shall be a member of J.U.L.I.E. and follow their rules and regulations." Added under warnings was "A 911 address sign which conforms to the specifications of the County Ordinance for size, color and reflectivity shall be placed and maintained by the owner/operator at the entrance of each WECS access road from a public road. A sign or posting no more than four square feet in area shall be placed and maintained in conjunction with, but in a subordinate position of that same 911 sign and shall provide the tower number(s) and a toll-free telephone number, answered by a person twenty-four hours a day seven days per week, for emergency calls and informational inquires." Also added was "no wind turbine generator tower or anemometer tower or site shall include any advertising sign, but logos of the Owner or Operator or the wind turbine generator manufacturer shall not be considered advertising for the purpose of this Ordinance." Added on page eight number four was "another method of protection for general safety may be officially presented to the County Engineer for his approval." The original number three was taken out and replaced with the 911signage language.

Mr. Krumwiede made a motion to approve the above changes. Mr. Lemenager seconded the motion.

A roll call was conducted. These changes were approved unanimously.

[The following paragraphs were removed for separate consideration per action taken by the full County Board on April 12, 2011.]

Ms. Schleef said the next is setbacks. The change is for "1,000' for participating property owners and 1,500' for non-participating property owners." The next change would be number four "any WECS site proposed within one and a half mile of the corporate limits of any incorporated village or city shall require a signoff by that corporate authority." Also added was "WECS towers will be able to be sited only in A-1 zoned areas, except as otherwise waived by the above referred to village or city. A two-mile radius around an existing private airstrip recognized by the FAA will be left free of wind turbines. The airstrip owner may waive this regulation."

Mr. Deany made a motion to approve the revised setback regulations. Mr. McTaggart seconded the motion.

A roll call was conducted. Voting "aye" were Mr. Deany, Mr. Lemenager, Mr. McTaggart, Mr. Meyer, Mr. Pursley, Mr. Schultz, and Ms. Wasmer. Voting "nay" were Mr. Krumwiede and Mr. Zumwalt. Motion carried.

Ms. Schleef said on page eleven was added, "the applicant shall proved all studies to be updated to the final number, size, etc. of towers to be in the final plan". The last was indemnification "the applicant, owner and/or operator of the WECS project shall defend, indemnify and hold harmless the County of Iroquois and its officials from and against any and all claims, demands, losses, suites, causes of action, damages, injuries, costs, expenses and liabilities whatsoever, including attorney's fees, without limitation arising out of acts of omissions of the

applicant, owner and/or operator associated with the construction and/or operation of the WECS project."

Mr. Pursley made a motion to approve these changes. Mr. McTaggart seconded the motion.

A roll call was conducted. These changes were approved unanimously.

The meeting was called order.

County Highway Engineer Moore told the committee he has checked the ATC requirements and all the bidders have the correct cashier check required. The bids were opened.
