PUBLIC COMMENTS

Dr. Gregg Murphy, I-KAN Regional Superintendent of Schools, spoke to the Board regarding a motion that was made during the Finance Committee meeting which would result in the reduction of funding to the I-KAN Office. He urged the Board to reconsider this action and asked the Board to continue funding at the current level and stick with the amount that was budgeted in Iroquois County's FY15 Budget.

Jim Wasser, a retired union electrician from Kankakee County, urged the Board to vote down a proposed Resolution which would support right to work zones in Illinois. He said right to work zones will encourage employers to offer lower wages to their employees while continuing to charge the same price for their services.

Steve Pfingsten Local 751 Field Representative provided the Board with a legal opinion from the Attorney General which concludes the right to work and empowerment zones are illegal. He said the turnaround agenda is a back door anti union effort that will drive down wages.

Mike Matejka with Laborers International Union of North America asked the Board to table discussion of the Resolution in support of right to work zones and encouraged the Board to stay out of the middle of conflict. He said people need to be able to make a decent living.

Pat Richards, member of the Carpenters Union, gave a brief history of unions and said this turnaround agenda has nothing to do with fixing a budget, but it will eradicate unions and the middle class.

Watseka resident P.J. McCullough dissected the 13 issues on Resolution in support of right to work zones. Overall, he said many of the points on the Resolutions are not favorable for employees or citizens. He mentioned unfunded mandates are sometimes for safety and worker's compensation policies protect employees and businesses. He also commented that the County should look for additional sources of revenue and be open to bringing more businesses to the County rather than discouraging growth.

County Board member Larry Hasbargen talked about calls he received from the Governor's office urging him to vote in favor of the turnaround agenda. With that, he did some research and did not find evidence that right to work destroys the economy.

Susan Vegovisch, President of AFSCME Local 3312, thanked those in attendance for speaking against the turnaround agenda.

County Board member Jean Hiles pointed out the amount of people in attendance at this meeting and said if the Board is discussing something controversial citizens will make it a point to come to the meetings whether day or night.

Pat McCullough, a retired farmer who also worked in a union, said right to work will make the economy worse. He has concerns about the amount of people within the County that are on public aid, in addition to the County Board's lack of interest in securing additional sources of revenue.

OUTSIDE COMMITTEE REPORTS

IEDA Director Ken Barragree updated the Board on projects that he has been working on within the County. He said Lyon is bringing in more jobs and their current facility will begin a 2^{nd} shift with the possibility of adding a 3^{rd} . He mentioned the Village of Clifton will be the home to a new Dollar General store. Also, there was a good prospect for the Bosch building, but they became disinterested; however, he will try his hardest to prevent that building from going in the route of the old Howard Industries building, which was razed. Lastly, there will be a series of seminars with IEDA and the USDA which will be held quarterly in Watseka through 2017. The seminars will be cosponsored by several groups, with the next one specific to grant funding and project funding. He encouraged attendance, stating that everyone is welcome.

The Board discussed at length the Resolution in support of the turnaround agenda which encourages local government empowerment and reform. Mr. Hasbargen felt adoption of this Resolution is bad for the County because of the anticipated reduction of wages should collective bargaining units be disbanded, which seems counterproductive. Mr. Hansen said the Resolution as presented was a non-binding advisory resolution. It's not changing the law its purpose is to encourage the General Assembly to pose a referendum to allow "our people" the right to vote on the matter. He also mentioned that Illinois is losing jobs to Indiana, which is a right to work state. Mr. Lamie felt the heart of this Resolution is to lower wages. He feels if the whole picture is looked at, other things should be looked at, such as worker owned co-ops. Mr. Bills remarked that the term "lowering wages" is not in the language of the resolution. After further discussion, it was moved by Mr. Rayman to send the Resolution back to committee due to the spelling errors in the Resolution presented. He then withdrew his motion. It was then moved by Mr. Hasbargen to correct the spelling errors. State's Attorney Jim Devine said that a separate motion was not necessary and the Board could adopt the Resolution with corrections as one motion. Mr. Hasbargen withdrew his motion. It was then moved by Mr. Rayman and seconded to adopt Resolution No. R2015-9, a Resolution supporting the Turnaround Agenda-Local Government Empowerment and Reform, with corrections. RESOLUTION NO. R2015-9

The Turnaround Agenda-Local Government Empowerment and Reform

WHEREAS, Illinois state law creates a "one size fits all" approach to collective bargaining for local units of governments. This approach creates added costs which are ultimately passed on to taxpayers.

WHEREAS, voters and local officials should determine what is a subject of bargaining-not the State.

WHEREAS, Local control of bargaining would allow voters of local governments to determine if certain topics should be excluded from collective bargaining, including contracting, wages, provisions of health insurance, use of employee time, required levels of staffing, procedures and criteria for personnel evaluations, academic performance, conduct, and discipline in school.

WHEREAS, State law sets thresholds for workers on state and local construction projects increasing costs significantly.

WHEREAS, State law has increased utilization of Project Labor Agreements for construction projects.

WHEREAS, Repealing the Illinois Prevailing Wage Law and the requirements for Project Labor Agreements would allow local governments more control over construction and project costs.

WHEREAS, More than 280 unfunded mandates have been imposed in recent years on communities across Illinois, costing those communities billions. Rolling back mandates will create more flexibility in local government budgets.

WHEREAS, Illinois' workers' compensation costs are the seventh highest in the nation-and more than double the costs in Indiana.

WHEREAS, Updating how injuries are apportioned to ensure employers pay for injuries that occur on the job, a clarification regarding the definition of "traveling employees" to ensure a reasonable standard that excluded risks that would impact the general public, and implementation of American Medical Association guidelines when determining impairment would result in major cost savings for local governments.

WHEREAS, Voters in our community should be allowed to decide via referendum whether of not employees should be forced to join a union or pay dues as a condition of employment.

WHEREAS, Local empowerment zones will help attract jobs and make our community more attractive for businesses.

WHEREAS, Local governments face unfunded liabilities that threaten core services and functions of government; state action on pension reform for future work should provide local governments the ability to address pension reform for future work as well.

THEREFORE, BE IT RESOLVED, Iroquois County endorses major reforms in state government that will encourage local control, reduce costs on local governments, empower local voters, and increase competiveness in our community.

Your Committee met at the Administrative Center on April 30, 2015 at 9:00 A.M. Members present were County Board Chairman Kyle Anderson, Kevin Hansen, Russell Bills, John Shure, Dale Schultz and Lyle Behrends. Dan Rayman and Troy Krumwiede were absent. Also present County Clerk Lisa Fancher, Treasurer Mindy Kuntz Hagan, Supervisor of Assessments Bob Yergler, ICPHD Administrator Dee Schippert, IEDA Director Ken Barragree, County Board member Charlie Alt, AFSCME Staff Representative Dave Beck, County employee Susan Vegovisch, Iroquois County resident P.J. McCullough, State of Illinois retiree Donald Price, Bradley resident Al Whitman, Carla Waters with the Times Republic, and Marvin Stichnoth.

The meeting was called to order.

During public comments, AFSCME Staff Representative Dave Beck spoke about the presented turnaround agenda and asked the committee to look at the points. He said the working men and women are at fault for the state's fiscal lows. Studies show the workers in right to work

zones make \$5,000 less per year. Mr. Beck urged the committee, once again, to reject the turnaround agenda.

Similar comments were voiced by County employee Susan Vegovisch, Iroquois County resident, P.J. McCullough, State of Illinois retiree Donald Price and Bradley resident Al Whitman

The Committee Chairs gave their monthly reports.

- Judicial Chairman John Shure reported normal reports will be received and a discussion will be held on the recent outages.
- Highway Chairman Russell Bills said his committee will discuss lettings for bridges and the annual striping.
- Management Chairman Lyle Behrends will open bids and the committee will take action on the Administrative Center and Jail roof project, Administrative Center parking lot resurfacing project and Administrative Center boiler project.
- The Finance Committee will receive their normal monthly reports.
- Tax Chairman Dale Schultz will review regular reports and discuss Animal Control with his committee.
- Supervisor of Assessments Bob Yergler reported the Planning & Zoning Committee has two appointments being presented for the Zoning Board of Appeals: Steve Rapp and Don Deany.
- The Health Committee is waiting on the Illinois Department of Health for grant funding.

County Board Chairman Kyle Anderson told the committee ESDA Director Eric Ceci was unable to attend the meeting and will be presenting his monthly report to the Finance Committee.

Anderson gave an update on the ETSB Advisory Panel stating the panel is leaning towards a Public Safety Tax and will possibly be added to the ballot at some point.

Anderson made the committee aware of County Board member Susan Wynn-Bence's last day being April 30th and there is now a vacancy on the County Board. Anderson said he would send a letter to Shane Cultra with this information.

Anderson gave an update on the forensic audit. Andrew Garrett with Garrett Discovery is expected to be in attendance at the County Board meeting on May 12th to present the results.

The committee held a discussion on the turnaround agenda that was presented to them last month for their review. It was moved by Shure and seconded by Hansen to adopt the turnaround agenda as a Resolution and send it to the Governor, President of the Senate, Speaker of the House and our local Representatives. A roll call vote was taken. Motion carried.

Anderson asked the committee for suggestions regarding parameters for public comments. At this time, a policy is not in force. Schultz and Shure agreed there should be some sort of policy set based upon subject matter and a time limit set. The committee will continue to discuss the matter in the following months.

The Board discussed the funding for the I-KAN Regional Office of Education. Mr. Schultz believes the funding for I-KAN should be kept at the current level as long as the County's budget is in good shape. He said there could be possible problems in the future, should the State cut its funding to local government, but for the time being the County can live with providing the amount that was budgeted for FY2015. Mr. Bills said the reason this motion was made during committee was to stay in line with the agreement with Kankakee County, which states funding will be provided based on EAV with Kankakee County responsible for 76% and Iroquois County responsible for 24% of the budget. There was some confusion among the Board regarding the contract and the I-KAN Budget. It was noted that the amount sent to I-KAN will be lowered if the Board follows the agreement, since Kankakee has lowered their portion of funding. After further discussion, it was moved by Schultz and seconded to leave funding for I-KAN Regional Office of Education at the established budgeted dollar amount. Motion carried by a roll call vote.

Your Committee met at the Administrative Center on May 7, 2015 at 9:00 A.M. Members present were Kevin Hansen, Bret Schmid, Russell Bills, and Dan Rayman. Charlie Alt and Ernie Curtis were absent. Also present County Board Chairman Kyle Anderson, Finance Director Anita Speckman, Probation Supervisor Barb King, Supervisor of Assessments Bob Yergler, County Clerk & Recorder Lisa Fancher, Treasurer Mindy Kuntz Hagan, ESDA Director Eric Ceci, County Board member Jean Hiles, Randy Schuldt of Schuldt Insurance, Suzie Werner of HomeStar Insurance, and Ginger Boas with University of Illinois Extension.

The meeting was called to order.

There were no public comments.

Randy Schuldt reported two squad cars from the Sheriff's department were removed from the County's insurance policy.

Suzie Werner of HomeStar Insurance stated the December 1st open enrollment change with all vendors is transitioning well. Also, a recent meeting regarding an upcoming health fair for County employees went well and she will keep the committee informed.

Ginger Boas with University of Illinois Extension provided a Fiscal Year 2015 budget and discussed their levy. Ms. Boas noted their budget runs from July 1st through June 30th. The Annual Budget Plan explains the total matchable revenue for Iroquois County at \$101,300. Ms. Boas explained this pays to have their local office and staff. It also funds many programs. She also let the committee know the levy has remained steady for the past four years.

The Department Heads gave their monthly reports. They are as follows:

- ESDA Director Eric Ceci is continuing to reach out to local jurisdictions. Ceci reported he received his hand radio technician license
- Treasurer Mindy Kuntz Hagan informed the committee with the combined effort of the Assessment office and the County Clerk's office, the tax bills have been mailed and payments are already being received.

(The following paragraph was removed for separate consideration per action taken by the full County Board at their May 12, 2015 Recessed Session meeting.)

The committee held a discussion on the IKAN budget issues. Finance Director Anita Speckman referred to the spreadsheet Mr. Gregg Murphy presented last month to the committee. The spreadsheet explains the percentage decrease from Kankakee, which would result in a \$13,987 reduction from Iroquois County. After further discussion, it was moved by Russell Bills and seconded by Dan Rayman to pay the County's IKAN proportion based on EAV as stated in the existing agreement. A roll call vote was taken. Motion carried.

ESDA Director Eric Ceci discussed the HMEP (Hazardous Material Emergency Preparedness) grant he recently applied for. Ceci told the committee the grant has been reduced and instead of being 100% reimbursable, there is only an 80% match. Ceci provided a reference sheet to the committee explaining how the funds will be spent if the County will provide the remaining 20%. It was moved by Rayman and seconded by Bret Schmid to increase ESDA's office expense line for the current fiscal year in the amount of \$644.03 for the HMEP Grant. A roll call vote was taken. Motion carried.

County Board Chairman Kyle Anderson updated the committee on the Blunk loan stating signed papers on the new agreement should be in hand by Tuesday.

The committee reviewed claims. It was moved by Schmid and seconded by Bills to pay the bills subject to County Board approval. A roll call vote was taken. Motion carried.

Under new business, Speckman explained the Management Committee opened bids for the boiler replacement on May 4th. The budget for the project is \$75,000 and the bids came in at \$87,950 from C&C Plumbing, \$125,000 from Dodson Plumbing and \$144,670 from Glade. The committee decided to speak with Henneman about why they project bids came in higher than expected and also to speak with C&C Plumbing about the accuracy on their bid. If the bid is awarded to C&C Plumbing, we will be over budget. However, bids for the Jail roof replacement were awarded and came in under budget by approximately \$25,000. The Management committee would like approval from the Finance committee to reduce funds from the Jail roof project and to cover the shortage for the boiler replacement project. It was moved by Bills and seconded by Schmid to reduce Capital Improvement Fund-Jail Roof (145-710-81306) by \$23,000 and add a new line for Boiler Replacement (145-710-81314) in the amount of \$23,000. A roll call vote was taken. Motion carried.

As there was no further business to come before the committee, it was moved by Bills and seconded by Schmid to adjourn at 10:04 A.M. Motion carried by a voice vote.

It was moved by Mr. Hansen and seconded to remove from the report for separate consideration, the paragraph that refers to the acceptance of the bid for the rubber roof at the jail from Slagel Insulation, Inc. and change the bid approved to the bid for the rubber roof in the amount of \$67,784.00 from Langlois Roofing, Inc. Your Committee met at the Administrative Center on May 4, 2015 at 9:00 A.M. Members present Lyle Behrends, John Shure, and Charlie Alt. Larry Hasbargen arrived late. Donna Crow and Adam Zumwalt were absent. Also present County Board Chairman Kyle Anderson, Finance Director Anita Speckman, Maintenance Supervisors Larry Pankey and Clyde Meents, County Board member Jean Hiles, and Nate Tegtmeyer with Freehill Asphalt, Inc.

The meeting was called to order.

There were no public comments.

It was moved by John Shure and seconded by Charlie Alt to amend the agenda to open the bids for the boiler first. The motion died due to the lack of a quorum.

Management Chairman Lyle Behrends moved forward with opening bids for the parking lot resurfacing project. One bid from Freehill Asphalt, Inc. was received in the amount of \$22,016.25. Mr. Tegtmeyer made the committee aware of patch work that should be completed before the sealing work begins.

Behrends proceeded to open the bids for the roofs at the Administrative Center and Jail. The two bids were received are as follows:

At this time Mr. Hasbargen arrived at the meeting.

After the committee reviewed the bid for the parking lot resurfacing with Mr. Hasbargen, it was moved by Shure and seconded by Alt to approve the parking lot resurfacing bid from Freehill Asphalt, Inc. in the amount of \$22,016.25 under the stipulation that work will not begin until a decision has been made on the area that needs patched. A roll call vote was taken. Motion carried.

(The following paragraph was removed from the report for separate consideration per action taken by the full County Board at their April 12, 2015 Recessed Session County Board meeting.)

The committee then reviewed the bids for the roofing projects. It was moved by Alt and seconded by Hasbargen to approve the bid from Slagel Insulation, Inc. in the amount of \$63,313.00 for the roof at the Jail. Motion carried.

After that, they discussed waiting another month to make a decision on the Administrative Center roof due to the bids not being comparable, meaning one bid is for the

entire roof and the other is for one portion of the roof. It was moved by Alt and seconded by Shure to table the bids for the Administrative Center roof until more information is received. Motion carried by a voice vote.

Lastly, bids for the boiler replacement project were opened. They are as follows:

Finance Director Anita Speckman provided a breakdown of the \$75,000 boiler grant explaining once \$9,500 has been paid to Henneman Engineering for their services, only \$65,500 is remaining for equipment. Speckman said with the bid for the roof at the Jail coming in approximately \$32,000 under budget, the Management Committee can request the Finance committee transfer those funds to the boiler grant project. Maintenance Supervisor Clyde Meents noted all vendors who submitted bids for the boiler made a site visit. It was moved by Alt and seconded by Larry Hasbargen to accept the bid from C & C Plumbing & Heating Inc. in the amount of \$87,950.00, subject to review by Henneman Engineering and approval by the Finance Committee to transfer remaining funds from the Jail roof project to the Administrative Center boiler project. A roll call vote was taken. Motion carried.

Behrends reported there were no updates on the County Farm waterway.

Final approval has not yet been given for the FSA office.

Maintenance Supervisor Larry Pankey reported on the following:

- The generator has been placed on the cement slab and by the end of the week the piping for the gas will be complete. He will then be in contact with Metro Power for them to turn on the generator.
- The piping in the jail is complete. He hopes to complete the upper cell blocks next year. Behrends said due to the asbestos on the piping, this will need to be factored in during budget time.

Maintenance Supervisor Clyde Meents reported on the following:

- The Health Department requested to have their back room hooked to the generator. This work is complete. Speckman noted this will be paid for with grant money they had available.
- Meents said he contacted Glade to look over the glycol project. They agreed on some of the suggested plumbing changes, giving an approximate cost of \$14,770 for the project. When he spoke with Weber Plumbing, they stated they did not have the equipment necessary to do the project and elected to pass. The project can begin within the next ten days. Shure questioned the work on the glycol project and asked if the work would interfere with the boiler project. Meents said the glycol project is estimated to take only three days but he would make sure it does not interfere with the boiler project.

The committee reviewed the claims. It was moved by Shure and seconded by Hasbargen to pay the bills, subject to County Board approval. Motion carried by a roll call vote.

After last months meeting, Speckman provided copies of the County Farm contract to committee members to review. Behrends said the contract will be added to the June agenda for discussion.

It was moved by Shure and seconded by Alt to adjourn the meeting at 10:30 A.M. Motion carried by a voice vote.

Also present Sheriff Derek Hagen, Coroner Bill Cheatum, Probation Supervisor Barb King, States Attorney Jim Devine, Circuit Clerk Lisa Hines, and 911 Director Nita Dubble.

The meeting was called to order.

There were no public comments.

Sheriff Derek Hagen's monthly report for April included:

- Patrol had 553 calls for service for the month of April
- Year-to-date calls for service 1,960 (6% increase over 2014)
- Booked-in 70 prisoners for the month of April
- Year-to-date book ins: 267

- Average Daily Population April: 21
- Average length of stay for April: 25 days
- Year-to-date average population: 23
- Year-to-date average length of stay: 15 days
- Overtime in the Jail for April was 208 hours on the schedule (88 hours more than the previous month. OT will continue to increase due to employees taking vacation during May through August.)
- Part-time Correctional Officer worked 27 hours
- A Correctional Officer was taken to IMH ER for treatment after a physical confrontation with an inmate. One day of work was missed.
- Two squad cars were removed from the County's insurance policy.
- The new water lines in the lower east and lower west part of the jail are done.

Coroner Bill Cheatum reported a \$4,300 grant for equipment was received from the state last month. Cheatum held a brief discussion on Kankakee's budget issues. Their County Board has been asked to make drastic cuts which could result in closing the morgue. Cheatum said this affects us by making us go to Champaign, McClain or Will County. However, if the morgue remains open, the fees may increase.

Probation Supervisor Barb King told the committee four of her officers have completed forty hours of firearms training, passed psychological and have been allowed by Judge Kick to carry a weapon.

States Attorney Jim Devine reported to the committee his office is now fully staffed. Jean Hiles asked for an update on the murder trial. Devine said the new trial date is set for August 17th. Devine also said he recently indicted an individual on another murder case in Milford, Illinois.

Circuit Clerk Lisa Hines distributed her monthly report to the committee for review. Hines noted almost \$25,000 has been collected from Pioneer Credit since January. Hines told the committee she will be having three cameras installed in her office. The cameras will be directed towards where money is handled. Due to the traffic flow that comes in and out of her office, having the cameras will help with security and settle any disputes. This project will be paid out of automation or document storage, costing approximately \$1,500.

911 Director Nita Dubble issued her ETSB report for April:

- Total calls for service 1,825
 - Police 1,159
 - \circ Fire 107
 - Ambulance 329/196 change of quarters
 - \circ Coroner 22
 - Animal Control -12
- Last month 20% of 911 calls received were land line and 80% were wireless, with a total of 1,404 911 calls received.
- There were 4,001 non-emergency calls received
- Telecommunicators worked 147 hours overtime in April
- Director worked 68 hours on radio 52 hours of which was training
- Dubble reported a telecommunicator vacancy
- Dubble discussed the phone outage that occurred on April 20th. A line between Papineau and St Anne was cut resulting in no service for close to 20 hours.

- Dubble reported on the hostage situation and commended her staff for doing an excellent job.
- Dubble is still working with legislation. The House has until Friday to file any new legislation and ours has not been filed yet. Dubble said this is concerning.

Under old business, John Shure told the committee he was approached about some security concerns at the front entrance of the Courthouse. The way the security is set up now, an individual could enter the courthouse and put the guard out of commission without anyone in the building knowing. Shure said there should be some other way making individuals walk through the metal detector before they have a chance of putting the guard out of commission, such as installing bullet proof glass. Shure told the committee this is something to think about as far as costs are involved and what other options there may be. Hines and Devine said Judge Lustfeldt suggested having a uniformed officer in the building. Shure said the matter will be discussed in more detail next month.

Your committee met at the Administrative Center on May 8, 2015 at 10:15 A.M. Members present were Dan Rayman, Ernie Curtis, Troy Krumwiede, and John Shure. Adam Zumwalt and Donna Wasmer were absent. Also present Supervisor of Assessments Bob Yergler.

The meeting was called to order.

There were no public comments.

Supervisor of Assessment Bob Yergler reviewed the monthly office report. Yergler reported April was a good month for building permits. He also reported quite a few kennel fees, campground licenses and mobile home licenses. Overall, 15 permits were issued -5 for agricultural and 10 residential. Yergler distributed a monthly report printed from the Devnet system with detailed information about the fees and activity for the month.

Yergler said there will not be a Zoning Board of Appeals meeting held this month but there will probably be one scheduled for June. There is a case open now with a kennel owner that has an existing license but would like to increase the number of dogs they handle. This will need to be presented to the Zoning Board.

Yergler made the committee aware of an employee that retired in the Zoning Office and his office is transitioning. A new plumbing inspector has been hired and two appointments to the Zoning Board of Appeals will be presented to the County Board: Steve Rapp and Don Deany. Once approved by the County Board, the Zoning Board of Appeals will be fully staffed.

The committee discussed the Regional Planning Commission. At a previous County Board meeting, County Board member Dale Schultz questioned the legality of disbanding the Regional Planning Commission. Dan Rayman contacted States Attorney Jim Devine about the matter and Devine agreed with Schultz. Devine said, in his opinion, the Regional Planning Commission should be left disbanded until the County is in financial shape to take it back on and it should not be removed from any ordinance, including subdivision ordinances.

Rayman reminded the committee of the Subdivision Ordinance that was sent back to the committee last month. He suggested the matter be tabled until next month to give the committee more time to review it and make additional changes, including the wording on maintaining the Regional Planning Commission. John Shure asked Rayman if Devine provided him with the statute stating we have to have a Regional Planning Commission. Rayman said Devine did cite the statute to him but he is unsure of what it was. This is something Devine can discuss in detail at the County Board meeting. It was moved by Ernie Curtis and seconded by Troy Krumwiede to table the matter of Subdivision Ordinance revisions. A roll call vote was taken. Motion carried.

The committee reviewed claims. It was moved by Shure and seconded by Curtis to pay the bills subject to County Board approval. A roll call vote was taken. Motion carried.

Under old business, Shure wanted to update the committee on House Bill 3523. Last month a resolution opposing HB3523 was sent to the County's State Representatives and the Governor in Springfield. Shure said the bill was approved in the House and sent to the Senate. The Senate Committee approved it and it is going to the Senate Floor, where it will likely be approved. Shure also discussed Senate Bill 920, which is sponsored by State Representative Jason Barickman.

Yergler stated he spoke with State's Attorney Devine about some of the complaints he is receiving in his office and how to properly handle them. For example, garbage in individuals' yards or lawns needing mowed. Mr. Devine told Yergler he didn't believe had the proper authority to respond to these complaints as they appear to be Health Department related issues. Moving forward, Yergler said, he will begin to redirect such complaints to the Health Department.

Your committee met at the Iroquois County Highway Building on May 8, 2015 at 9:00 A.M. Members present were Russell Bills, Kevin Hansen, Dale Schultz, and Larry Hasbargen. Charlie Alt, Jean Hiles, and Donna Crow were absent. Also present County Engineer Joel Moore, County Board Vice Chairman Dan Rayman, representatives from Beniach Construction, Big O Services, Terra Firma Soils, Newell Construction, and IPC, Sheldon Highway Commissioner Jim Yana, Beaver Highway Commissioner Gary Barnlund, and Ford County Highway Engineer Greg Perkinson.

The meeting was called to order.
