PUBLIC COMMENTS

Mr. Hasbargen spoke to the Board about the cost of the Iroquois County Health Department and the fact that it is costing more money for fewer employees and reduced services than the former Ford Iroquois Health Department. He went on to say that when the former Health Department was dissolved, it was conveyed to the Board that the organization of an independent Health Department would cost the taxpayers less money. He also questioned the legality of the Health Department giving money to the County when the money was earmarked for the Health Department, not the County. In closing, he wanted to make the public aware and point out that past decisions of the County Board are costing them.

OUTSIDE ORGANIZATION REPORTS

IEDA Director Ken Barragree informed the Board of the following:

- Berkot's production area, also known as their commissary, could still be incorporated at their Watseka location. The building guidelines for the City of Watseka have hindered the process, but Ken has been working with the city to come up with a resolution and they have offered to adjust the current abatement which was well received by Berkot's IEDA is also offering a revolving loan with the hope that it will entice Berkot's to proceed with their original plan.
- T & D, in Watseka, will be adding approximately 50,000 square feet to their facility, which will create new hiring.
- Alexander Lumber has purchased the People's Lumber in Watseka; however, the redi-mix portion of the business will remain as People's.
- IEDA is continuing the co-sponsorship with USDA of workshops that focus on but aren't limited to economic development and web & social media engagement.

Ken encouraged the Board members to attend the workshops and thanked those who have been in attendance.

Your Committee met at the Administrative Center on October 29, 2015 at 9:00 A.M. Members present were County Board Chairman Kyle Anderson, Kevin Hansen, Russell Bills, John Shure, Dale Schultz, and Lyle Behrends. Dan Rayman and Troy Krumwiede were absent. Also present County Clerk Lisa Fancher, Finance Director Anita Speckman, Supervisor of Assessments Bob Yergler, ICPHD Administrator Dee Schippert, ESDA Director Eric Ceci, County Engineer Joel Moore, IEDA Director Ken Barragree, County Board members Donna Crow, Larry Hasbargen, and Jean Hiles.

The meeting was called to order.

There were no public comments.

The Committee Chairs gave their monthly reports.

- Highway Chairman Russell Bills stated the committee will review the monthly claims.
- Finance Chairman Kevin Hansen said the budget will be finalized this month.
- Management Chairman Lyle Behrends and the committee will discuss County Farm management issues. Also, there will be discussion on access to the soccer field, which is located north of the Administrative Center, due to the possibility of it being sold.

- Tax Chairman Dale Schultz will receive the normal reports, review animal control and discuss the finalization of the levy.
- Judicial Chairman John Shure reported normal reports will be received and the committee will finalize discussion on hiring a part time public defender to reduce costs.

ESDA Director Eric Ceci has been working with the Long-Term Recovery Committee. Ceci has updated the Emergency Operations Plan and turned it in to the Regional Coordinator today. The initial review is set for November 5th. Ceci also finished the draft of hazardous material response plan which goes before the LEPC on November 10th. Lastly, Ceci noted he would like to host a meeting to discuss exercises for the foreseeable future.

County Board Chairman Kyle Anderson said there will be an appointment made to the 377 Board at the County Board Meeting.

The committee discussed Municipal Code. County Clerk Lisa Fancher explained the first year of online use is coming to an end and beginning February 2016 the charge to continue with the online service is \$550 each month. Fancher noted she has several hard copies of Municipal Code available in her office. It was moved by Behrends and seconded by Hansen to discontinue the online usage of Municipal Code at the end of the free trial. A roll call vote was taken. Hansen, aye; Bills, aye; Shure, aye; Schultz, nay; Behrends, aye; Anderson, aye. Motion carried.

Correspondence included a letter received by Anderson regarding a landfill by Milford. Anderson said this is something that requires more investigation as he just received the letter before the meeting started. Also, the 2016 County Board meeting schedule was distributed. A motion to approve the meeting schedule will take place at the full County Board meeting.

The committee reviewed claims. It was moved by Shure and seconded by Schultz to pay the bills subject to County Board approval. A roll call vote was taken. Motion carried.

Under old business, County Board member Larry Hasbargen stated he picked up a copy of the cd from the Public Health forensic audit. He said he hasn't had the opportunity to view it yet but he has heard from others that the computers listed on the cd do not have names, they are numbered. Anderson agreed there are no names on the cd. He said there is another cd that is in States Attorney Jim Devine's possession but it has information that needs to be redacted.

Under new business, Supervisor of Assessments Bob Yergler informed the committee he attended a meeting in Springfield earlier in the week and learned of Senate Bill 1488. Yergler said this bill is currently in veto session and is one to be aware of. It was a pretty simple bill to adjust language in the general homestead exemption but there are a couple of items added to it. Yergler explained if the bill passes with the amendments, the County Board has the right, within six months of the bill being passed, to increase the general homestead exemption from \$6,000 to \$14,000 by Board Resolution. Yergler said in just our County, we have over fifty million in general homestead exemption reduction. If we increase to \$14,000, it would add another seventy million because we have over 8,800 single family homes. Yergler stated this bill could pass and the County Board has six months to decide whether we want to do it or not.

Due to the upcoming holiday, the next Policy & Procedure Committee meeting will be held on Wednesday, November 25th.

Ceci told the committee he received a call from an Iroquois Township Trustee regarding a quarry that might be going up in Indiana. Ceci said he hasn't read into the issue much yet but this is something that could cause us more flooding problems.

As there was no further business to come before the committee, it was moved by Schultz and seconded by Bills to adjourn at 9:22 A.M.

Your Committee met at the Administrative Center on October 13, 2015 at 10:45 A.M. Members present were Bret Schmid, Charlie Alt, Russell Bills, and Ernie Curtis. Kevin Hansen and Dan Rayman were absent. Also present County Board Chairman Kyle Anderson, Finance Director Anita Speckman, Supervisor of Assessments Bob Yergler, States Attorney Jim Devine, ICPHD Administrator Dee Schippert, Treasurer Mindy Kuntz Hagan, County Clerk Lisa Fancher, ESDA Director Eric Ceci, County Engineer Joel Moore, Carla Waters from the Times Republic, and County Board members Larry Hasbargen, Jean Hiles, Donna Crow, Lyle Behrends, and John Shure.

Finance Committee Vice Chairman Bret Schmid called the meeting to order.

There were no public comments.

The committee discussed the proposed FY2016 budget which was placed on file in the County Clerk's Office. The proposed budget shows a deputy clerk position listed under the County Board section of the budget. In the past, funding for this position has been shared between the Treasurer and Animal Control respectively, until the Treasurer chose to eliminate the Animal Control duties from her office. This change in duties preformed by the Treasurer will affect one employee who will be laid off from the Treasurer's Office; however, that employee will have the chance to apply for the newly created position which will be under the County Board. County Board Chairman Kyle Anderson explained that this part time clerical position will work solely with Animal Control.

After being notified of the changes, the AFSCME Union presented Chairman Anderson with a Memorandum of Agreement, which would guarantee that the employee from the Treasurer's Office would not lose her full time employment as well as her benefits. The agreement, written by AFSCME, would provide that the employee would work on Animal Control 19 hours per week and the remainder of the work week the employee would be used as a "floater" in the Treasurer, Assessment, and County Clerk and Recorder's, and County Board Offices. Chairman Anderson spoke with the two Elected Officials and Department Head from each of the offices, two were agreeable to the idea.

At this time, State's Attorney Jim Devine spoke of the need for a part time clerical position in the Probation Department. He said the Probation Department has voiced their need for a part time secretary on many occasions since the retirement of their former full time secretary, a position that was not filled due to budget cuts several years ago.

There was general discussion regarding the aforementioned position and whether or not it should be a full or part time position. Finance Director Anita Speckman noted that should the Board choose to make this position a full time position it would have a \$12,500 impact on the General Fund in the FY2016 budget. It was the opinion of the State's Attorney that this was not a material change; therefore, the budget would not have to be reposted should the Board decide to make this a full time position.

It was the consensus of the committee that more time would be needed before a decision could be made on the information presented. A representative from the Board will need to speak

with Probation Director Tom Latham, to see if he can or will fund the position for the additional salary, or 16 additional hours a week, in addition to the cost of health insurance. There will also need to be an understanding that the position would be an AFSCME Union position and it would be under County Board authority.

The committee discussed briefly general information contained in the budget and whether or not the County Board has control over the compensation of employees at Mental Health and Public Health. State's Attorney Jim Devine said County Board only has the authority to levy for taxes and the Mental Health Board and Board of Public Health have the authority to fix compensation for employees.

As there was no further business to come before the committee, it was moved by Mr. Curtis and seconded to adjourn the meeting at 11 A.M. Motion carried by a voice vote.

Also present Finance Director Anita Speckman, Sheriff Derek Hagen, Supervisor of Assessments Bob Yergler, 911 Director Nita Dubble, ICPHD Administrator Dee Schippert, Treasurer Mindy Kuntz Hagan, County Clerk Lisa Fancher, County Board member Larry Hasbargen, Randy Schuldt of Schuldt Insurance and Suzie Werner of Homestar Insurance Services.

The meeting was called to order.

There were no public comments.

Randy Schuldt of Schuldt Insurance reported Finance Director Anita Speckman contacted him regarding an easement to the soccer field and if there would be any issues with the use of our parking lot. Schuldt stated he didn't foresee any issues. Schuldt is also working on policy renewals but doesn't expect big changes.

Suzie Werner of Homestar Insurance Services said she is continuing to prepare for the County's benefits fair in November.

The committee briefly discussed the 2016 budget. It was moved by Russell Bills and seconded by Ernie Curtis to approve the fiscal year 2016 budget. A roll call vote was taken. Motion carried.

Speckman informed the committee the fiscal year 2015 audit has begun. The auditors will be here December 14th through December 18th for preliminary testing. The full audit team will be here January 11th through January 22nd. Speckman said she has already distributed the request lists of all the paperwork the auditors need.

The Department Heads gave their monthly reports. They are as follows:

- Treasurer Mindy Kuntz Hagan provided a report of state payments and said we are within \$1,500 of what we received last year. The Use Tax is in a backlog and we have not received any payments since August. Kuntz Hagan said we will get the monies but we aren't sure when. Also, the tax sale held on October 26th went well.
- 911 Director Nita Dubble continues to work on legislation. Dubble reported there are two counties closing the doors to their 911 Centers. Dubble spoke about House Bill 4305 which involves Motor Fuel Tax, lottery and 911. As of January 1st, the only income 911 will have coming in will be the December revenue. They have also lost all wireless and the last wireless check was received in August.

- Supervisor of Assessments Bob Yergler said the Board of Review is in session and receiving complaints until the end of the month. We received our tentative multiplier of one from the state. During Policy & Procedure and Tax, Yergler spoke about Senate Bill 1488. It was originally a bill to clean up language in the general homestead exemption. Senator Barbara Flynn Currie added language to increase the general homestead exemption from \$6,000 to \$14,000.
- Sheriff Derek Hagen told the committee he was able to locate two squad cars for purchase and can have them equipped for less than the amount he budgeted. Hagen said one of the unmarked vehicles transmissions went out. The other two unmarked vehicles have very high mileage. Hagen requested the purchase of a vehicle to replace one of the unmarked vehicles if monies become available. As Hagen reported in Judicial, calls are up about 3% higher than last year. Hagen also has an officer out on workmans compensation.
- ICPHD Administrator Dee Schippert reported there has been a lot of media on public health departments. Schippert expressed that our health department is not at a point of needing to layoff staff. We have other sources of revenue coming in.

There were no updates on the Blunk loan. At the last Finance meeting, State's Attorney Jim Devine said he would have figures soon. Hansen suggested asking Devine for an update at the full County Board meeting.

The committee reviewed claims. It was moved by Bret Schmid and seconded by Charlie Alt to pay the bills subject to County Board approval. A roll call vote was taken. Motion carried.

As there was no further business to come before the committee, it was moved by Alt and seconded by Russell Bills to adjourn at 9:31 A.M. Motion carried by a voice vote.

HEALTH

Mr. Schultz, Vice Chairman of the Health Committee, gave the report of his committee. The Board began a lengthy discussion regarding the authorization of claims from the Iroquois County Public Health Department. Currently, the claims are presented to the Board of Health and then passed on to the County Board Health Committee followed by the full County Board before they are ultimately approved. It is the opinion of State's Attorney Jim Devine, according to statute; the Board of Health has the autonomous right to exist, therefore the right to establish internal rules of approving claims which includes final authority to approve claims.

Several Board members questioned the want for change in the approval process of the claims. The current protocol was put into place, as a way of ensuring the claims are reviewed monthly before they are paid because the Board of Health only meets approximately 6 months out of the year. County Board member and Board of Health President John Shure explained that the Board of Health has set up a Finance Committee, consisting of 3 members from the Board of Health. Their Finance Committee will convene during the months the full Board of Health does not meet, in order to approve the claims. In turn, this lead to the County Board members questioning the legality of a committee, which isn't a quorum of the entire Board, approving payment of bills. State's Attorney Jim Devine said that while the County Board has every right to be suspicious after what happened with the Ford Iroquois Public Health Department; this is a set of controls that minimally meets accountability. It was noted the Finance Department will process the checks for the claims from the Health Department at the same time as the checks for the claims which are approved at the County Board meetings. Many members of the County Board would like to receive a list of claims approved each month by the Board of Health and its Finance Committee, although it is not mandatory.

After the discussion closed, it was moved by Mr. Schultz and seconded to approve the Health Committee report. Motion carried by a roll call vote.

The Health Department is looking into a new billing system that allows them to accept private health insurance. A grant was applied for and they were awarded \$3,000 for the full cost of the set-up.

Under old business, Board of Health President John Shure spoke about the matter of the Board of Health approving claims for the Health Department. - C&C Plumbing have been on-site to look at the boilers due to recent issues.
- The floor in the lab area of the Health Department is scheduled to be stripped and re-waxed in mid-November.
- Heatpump #6 is scheduled for replacement in November.

Maintenance Supervisor Larry Pankey reported on the following:

- Pankey was asked last month about receiving help with snow removal from those who need community service hours. After looking into state statutes and speaking with the judges, the County isn't liable if the individuals are hurt while performing these services.
- A fall clean-up is needed for the buildings, as stated in the mowing contract.
- Pankey and Meents will get a pallet of salt for the parking lot at the Administrative Center, Courthouse, and Jail for the winter.

Nordmeyer quoted \$900 but the amount does not include installation, either. Iroquois Print quoted \$1,400, which does include installation. Hagen said it would make more sense to replace the vehicles rather than putting thousands of dollars of repair into them. For 2016, two marked squads are already lined up for purchase.

Probation Supervisor Barb King said Probation Director Tom Latham is working on a data report to present to the committee for December or January. There are currently four kids in detention in October for forty five days costing \$3,825. Also, there are eight kids receiving redeploy services through the redeploy grant.

Judge James Kinzer spoke about the hiring of a second Assistant Public Defender, as discussed in previous meetings. Kinzer said he would like to negotiate with Joe Anthony on a trial basis for \$1,500 per month. The position would not include IMRF benefits or health insurance. Kinzer believes the hiring of a second Assistant Public Defender will save the County money. Kinzer also added that there are two lawyers being used by the judges that are leaving the community.
