PUBLIC COMMENTS

Jed Whitlow, District II County Board member, addressed the need for the Board to support the Public Safety Tax Referendum that will appear on the ballot at the November General Election. He said financial constraints are a problem with the Sheriff's Department, which many days only has one deputy on duty to cover the 1,120 square miles of the County. Two deputies are off on worker's comp, calls are up, and there is no surplus of money to address the needs to provide adequate service for the citizens of Iroquois County. In closing, he reiterated the need to support the tax, he feels it is not unreasonable and is a small request for the benefits reaped.

John Zumwalt with the Ford-Iroquois Farm Bureau talked about land that is included in a proposed footprint of a US Fish and Wildlife refuge area in the Northeastern part of Iroquois County. Because of what has been seen in the Southern part of the State with one of these refuge areas, he feels they will not work with Drainage District Commissioners or local farmers. In addition, they will not be paying taxes on the land that is within the footprint of the refuge. The Friends of Kankakee are asking the County to quit claim a parcel of land to their organization, which John believes will feed the monster and we will witness what has happened in Southern Illinois with their refuge, as well as other parts of the State. He urged the Board to stay on top of this matter.

CHAIRMAN COMMENTS

Chairman Anderson noted there will be a special Finance Committee meeting which will be held at 9 A.M. on September 15, 2016. The time of the meeting was inadvertently left off the Meeting Schedule which was distributed before the meeting.

Your Committee met at the Administrative Center on September 1, 2016 at 9:00 A.M. Members present were County Board Chairman Kyle Anderson, Kevin Hansen, Russell Bills, John Shure, and Lyle Behrends. Dan Rayman, Jed Whitlow, and Troy Krumwiede were absent. Also present Finance Director Anita Speckman, County Clerk Lisa Fancher, Treasurer Mindy Kuntz Hagan, IEDA Director Ken Barragree, Supervisor of Assessments Bob Yergler, County Engineer Joel Moore, County Board members Larry Hasbargen and Jean Hiles, and Wendy Davis with the Times Republic.

The meeting was called to order.

On behalf of the Iroquois County Historical Society, County Board member Jean Hiles invited the County Board to hold the October or November monthly meeting in the Old Courthouse Museum. The Old Courthouse is 150 years old this year. The meeting will be held in the old courtroom. Hiles said a tour of the building is also being planned and all members are invited to attend. Russell Bills stated the County Board meeting has been held in the old Courthouse before and John Shure suggested holding the October meeting there rather than the November meeting. County Board Chairman Kyle Anderson told Hiles he would meet with her to discuss the details.

The Committee Chairmen gave their monthly reports.

- Highway Chairman Russell Bills said the Highway Committee will be reviewing issues regarding the Motor Fuel Tax audit and changes within the accounting procedures.
- Finance Chairman Kevin Hansen reported budget discussions will continue. The current budget shortfall is either \$53,000 or \$93,000 based on a couple of determining factors.
- Management Chairman Lyle Behrends and the Management Committee will receive their normal reports.
- Judicial Chairman John Shure reported normal reports will be received from the department heads. There will be some discussion held with Sheriff Derek Hagen regarding recent activities in the Sheriff's Department. Shure also invited the newly appointed judge to attend the meeting.
- A Zoning Board of Appeals meeting was held on August 30th which resulted in approval to increase a dog kennel license.

Appointments to be sent to the County Board include Don Deany as Chairman of Zoning Board of Appeals.

The committee reviewed claims. It was moved by Behrends and seconded by Bills to pay the bills subject to County Board approval. A roll call vote was taken. Motion carried.

Under new business, Behrends asked County Clerk about the Illinois voting system being hacked and how it directly affects us. Fancher said according to the attorney for the State Board of Elections, they believe no data was changed, altered or eliminated. Fancher also said it wouldn't affect our election equipment in any way because they aren't connected to the internet.

Anderson asked County Board member Larry Hasbargen for an update on the county wide recycling day. Hasbargen met with the recycling vendor at Big R and showed them where to park their trailers. Hasbargen also contacted the local newspaper about placing an ad for the event. The cost for the ad is \$340. The radio station will run an ad two times a day for ten days for \$100. Hasbargen will present these options to the Finance Committee.

As there was no further business to come before the committee, it was moved by Hansen and seconded by Behrends to adjourn at 9:21 A.M. Motion carried by a voice vote.

Your committee met at the Administrative Center on September 8, 2016 at 9:00 A.M. Members present were Bret Schmid, Charlie Alt, Ernie Curtis, and Dan Rayman. Kevin Hansen and Russell Bills were absent. Also present Finance Director Anita Speckman, County Clerk Lisa Fancher, Supervisor of Assessments Bob Yergler, Sheriff Derek Hagen, Probation Director Tom Latham, Treasurer Mindy Kuntz Hagan, 911 Director Nita Dubble, ICPHD Administrator Dee Schippert, Suzie Werner of HomeStar Insurance Services, Randy Schuldt of Schuldt Insurance, County Board members Larry Hasbargen and Jean Hiles, and Wendy Davis with the Times Republic.

The meeting was called to order.

County Board member Larry Hasbargen spoke to the committee about the county wide recycling event. He contacted the local newspaper and radio station about advertising the event. The newspaper will run a 3x5 ad for \$345 and the radio station will play the ad for five days for \$100. The County has an account with the newspaper and the ad does not need to be pre-paid but the radio station does require pre-payment. Hasbargen also asked for money to purchase water and ice for the volunteers. The committee agreed to pay for the advertisements per Hasbargen's request.

Randy Schuldt of Schuldt Insurance had no business to report to the committee.

Suzie Werner of HomeStar Insurance Services provided the committee with rate updates. The Health Alliance renewal started out at 9% and is now at 5%. Delta Dental renewal came in with a 3.4% increase and Kansas City Life came in with no increase on rates. EyeMed does not renew until 2018 but Werner can reach out to our previous provider, VSP, for a quote. Finance Director Anita Speckman explained she has had some feedback from employees that the coverage from EyeMed isn't as good as VSP. Werner also mentioned the benefits fair is scheduled for November 17th and November 18th.

The Department Heads gave their monthly reports. They are as follows:

- Treasurer Mindy Kuntz Hagan reported collection is at 79%. A total of \$38 million has been collected of the expected \$47 million. Also, we received a payoff check for the Gathering loan.
- Sheriff Derek Hagen updated the committee on the two deputies that are out on worker's compensation. He is unsure of a return date for both of them. Hagen spoke to the committee about the Public Safety Tax and said he has had several people approach him about what the tax will be used for. He believes it would be beneficial for the board to inform the public of what the tax will and will not cover. This can be done so in Committee and County Board meetings. For example, a portion of the tax could allow Hagen to hire more deputies.
- 911 Director Nita Dubble is in agreement with Hagen and distributed a proposed summary of what the Public Safety Tax can and cannot be used for. Dubble gave her own suggestions which include Code Red and items for next generation 911. Code Red allows text messages to be sent when an occurrence affects a community or county. This cost for this service is \$12,000. The software for next generation 911 is a program connected to the phones costing \$180,000. Both Hagen and Dubble are more than willing to speak to the public about the tax but would like to have the County Board's support.
- ICPHD Administrator Dee Schippert informed the committee the state currently owes the health department \$113,000.

Finance Director Anita Speckman prepared preliminary budget sheets for the committee to review. Speckman explained she included the adjusted lease renewals for the Administrative Center as discussed during the Management meeting. A budget shortfall of \$55,974 does not include filling the opening in the Probation office. A budget shortfall of \$63,844 does include filling the opening in the Probation office. Speckman said Probation Director Tom Latham feels strongly that this position should be filled and that 80% of the salary is reimbursed by the state. There is also an upcoming vacancy in the Assessment office that Supervisor of Assessments Bob Yergler would like to fill and has agreed to pay from the GIS Fund.

No activity has been made on the Blunk loan.

The committee reviewed claims. It was moved by Charlie Alt and seconded by Ernie Curtis to pay the bills subject to County Board approval. A roll call vote was taken. Motion carried.

It was moved by Curtis and seconded by Alt to pay \$100 to WGFA Radio for advertising for the county wide recycling event. A roll call vote was taken. Schmid, aye; Alt, aye; Curtis, aye; Rayman, nay. Motion carried.

Under new business, the committee decided to hold a special Finance committee meeting on September 15th at 9:00 A.M.

As there was no further business to come before the committee, it was moved by Alt and seconded by Rayman to adjourn at 9:34 A.M. Motion carried by a voice vote.

Your Committee met at the Administrative Center on September 7, at 1:00 P.M. Members present Lyle Behrends, Donna Crow, John Shure, and Larry Hasbargen. Adam Zumwalt, Charlie Alt, and Dan Joyce were absent. Also present Maintenance Supervisors Clyde Meents and Larry Pankey, Sheriff Derek Hagen, Finance Director Anita Speckman, Business Manager of D & S Farms Paul Corzine and Wendy Davis with the Times Republic.

The meeting was called to order.

There were no public comments.

Paul Corzine, Business Manager of D & S Farms, gave the committee an update on the County Farm as follows:

- Applied grass herbicide: Clethodim 2EC @ 8oz/acre
- Applied fungicide: Tetraban @ 6oz/acre
- Applied insecticide: Paradigm @ 3oz/acre

Finance Director Anita Speckman informed the committee she has been in contact with an AT&T representative about increasing the County's bandwidth. Speckman explained we are currently at 10mb and the representative would like to increase it to 50mb. The cost amounts to an increase of \$96 per year with no increase in the length of the three year contract. It was moved by John Shure and seconded by Donna Crow to approve the AT&T bandwidth increase from 10mb to 50mb at a cost of \$96 per year. A roll call vote was taken. Motion carried.

The committee discussed snow removal for the upcoming season. The maintenance supervisors handled the snow removal and salt spreading for the Administrative Center, Courthouse, and Jail during the previous year. Advertising for outside bids allows the committee to compare prices and establish future snow removal guidelines. It was moved by Crow and seconded by Larry Hasbargen to advertise for snow removal bids to be opened during the October Management committee meeting. Bid requests will also be posted on the County website. A roll call vote was taken. Motion carried.

Management Chairman Lyle Behrends and the committee reviewed the remaining Administrative Center leases. Each committee member was given a copy of leases for East Central Illinois Community Action Programs (Head Start), Volunteer Services of Iroquois County and Champaign County Regional Planning Commission – Workforce Development. Beginning with East Central Illinois Community Action Programs (Head Start), Shure noted the description in the lease does not include the garden area and the payment of rent does not state the dollar amount per square foot. It was moved by Shure and seconded by Hasbargen to approve the three year East Central Illinois Community Action Programs (Head Start) lease including use of the garden area with the proviso if said use proves unsatisfactory, the County reserves the right to discontinue the use of the garden area. The rental per square foot is \$6.73 for the term of the lease. A roll call vote was taken. Motion carried.

It was moved by Crow and seconded by Shure to approve three year leases for each Volunteer Services of Iroquois County and Champaign County Regional Planning Commission – Workforce Development at a rate of \$6.73 per square foot for the term of the lease. A roll call vote was taken. Motion carried.

The committee reviewed the claims. It was moved by Hasbargen and seconded by Crow to pay the bills subject to County Board approval. Motion carried by a roll call vote.

Maintenance Supervisor Clyde Meents reported some ongoing issues with garbage pickup. The current pickup schedule is Monday and Thursday. Meents said with Monday being a holiday, the garbage has yet to be picked up for the week. Behrends has tried to contact the vendor but has been unsuccessful.

Under new business, Shure asked the committee to re-visit the parking issue at the Administrative Center as he has noticed individuals parking in or near the grass area rather than the available parking spaces. Besides installing more signs, the committee is unsure how to address the issue at this time.

It was moved by Shure and seconded by Hasbargen to adjourn the meeting at 2:03 P.M. Motion carried by a voice vote.

TAX

Mr. Whitlow, Chairman of the Tax Committee, gave the report of his committee. At this time, the Board discussed the request from the Friends of the Kankakee, which would guit claim the County's interest in a parcel of land to their organization. The parcel is a sliver of undeveloped land in the Willow Estates area that is of no use to the County. State's Attorney Jim Devine said it appears the parcel in question, according to the plat of Willow Estates, was a proposed road which was never developed. Supervisor of Assessments Bob Yergler stated the Friends of Kankakee is a not for profit organization based out of Indiana. They have made arrangements with tax buyers to sell property, which is acquired in the Willow Estates area through the delinquent tax process, to their organization. After they obtain a deed to the property, the Friends of Kankakee then apply for exempt status from the Illinois Department of Revenue, which has been granted throughout the years. It is believed by some that deeding this piece of land will have an effect on a proposed US Fish and Wildlife refuge that is planned for the area. They feel if the County deeds their interest in this property, the Friends of Kankakee will deed all the property they have acquired to the refuge. Neither the State's Attorney or the Supervisor of Assessments think the 1.3 acres in question would have an effect on whether the refuge goes through or not. The Friends of Kankakee own a majority but not all of the land in that area. After further discussion, no action was taken on the matter. It was moved by Mr. Whitlow and seconded to approve the report of the Tax Committee. Motion carried by a roll call vote.

The meeting was called to order.

The committee reviewed the claims. It was moved by Dale Schultz and seconded by Bret Schmid to pay the bills subject to County Board approval. Motion carried by roll call vote.

It was moved by Troy Krumwiede and seconded by Schultz to amend the agenda to discuss Animal Control prior to public comments. Motion carried by a voice vote.

Dr. Youssef gave his report for August. There were a total of 44 cases with 14 dogs taken to the clinic. Dr. Youssef reported 6 dog bites. There were also 5 bats reported. All bats tested negative. Dr. Youssef introduced new staff members Animal Control Clerk Beth Utke and Animal Control Warden Jamie Fanning. Animal Control Clerk Beth Utke is working in the Administrative Center. She explained she is working through the changes on the new system and expects to be finished by January 2017. Jamie Fanning has taken on the position as the Animal Control Warden.

Under Public Comments, President of the Friends of the Kankakee Mary Ann Hahn addressed the committee about a piece of land they would like the County to quit claim deed to them. The committee agreed State's Attorney Jim Devine should continue to keep in direct contact with the Friends of the Kankakee attorney as well as the Tax Committee members.

The department heads gave their monthly reports.

- County Clerk Lisa Fancher reported the ballot has been set up and many rounds of proofing will now take place. She is also working on purchasing a new ballot printer, and a decision will be made this week.
- Treasurer Mindy Kuntz Hagan told the committee real estate taxes are 76% collected. A total of \$36.6 million has been collected of the expected \$47.9 million. The certified mailing process is expected to begin on September 30th with publications beginning the week of October 3rd and the tax sale on October 24th.
- Supervisor of Assessments Bob Yergler said his office will be ready to publish in October.

Member of the 377 Board Lou Strong spoke to the committee about their levy request. Their Board of Directors requests \$492,484 for the Arc of Iroquois County and ABRA, which is a 5% increase.

As there was no further business to come before the committee, it was moved by Krumwiede and seconded by Schmid to adjourn the meeting at 9:54 A.M. Motion carried by a voice vote.

Your committee met at the Administrative Center on September 6, 2016 at 10:00 A.M. Members present were Troy Krumwiede, Dale Schultz, Bret Schmid, and Jed Whitlow. Dan Pursley was absent. Also present ICPHD Administrator Dee Schippert, ICPHD Executive Assistant Cheryl Davis, County Board members Larry Hasbargen and Jean Hiles, Wendy Davis with the Times Republic, Jim and Anita Honn, Kenneth Duits, and Larry Wesemann.

The meeting was called to order.

Anita Honn, a resident of Danforth Township, addressed the committee regarding a neighbor who is storing chicken manure on their own property about a quarter to half mile away from her home. Mrs. Honn said the problem began in early April and she contacted Director of Environmental Health Terry Eimen but he was unable to help with the situation. She also contacted State's Attorney Jim Devine who directed her to the County Clerk's office. From there, Mrs. Honn got in contact with Health Chairman Troy Krumwiede and he came to the site and assessed the situation. Mr. and Mrs. Honn also provided pictures of the property discussed for the committee. The matter will be discussed at the County Board meeting on September 13th.

ICPHD Administrator Dee Schippert told the committee she will also check into the manure situation. Schippert informed the committee she had an employee of 25 years retire recently. The position has been filled; however, the newly retired employee is available for flu clinics or on an as needed basis.

Schippert reviewed the grants and contracts spreadsheet, stating all grants are finalized with some changes as follows:

- Dental Sealant grant decreased from \$1,500 to \$1,000
- Lead Testing Program decreased from \$1,890 to \$1,085
- Illinois Tobacco Free Communities Program remained the same at \$20,714
- Preschool Vision & Hearing Screenings Program remained the same at \$3,549

The summary report was review next. Schippert said temporary permits issued are still increasing due to the festivals and fairs going on. Mosquito samples are also on the rise but there are no human west nile cases in Illinois. Schippert pointed out the ten chlamydia cases for the month. Once you have more than a 50% increase, the state considers you in outbreak mode. All chlamydia cases have been followed up on and treated.

Schippert explained to the committee that Finance Director Anita Speckman provides a revenue and expense report for the Board of Health which consists of five different categories: Administrative, Healthy Families, Senior Services, Community Health, and Environmental Health. The Board of Health requested a summary sheet tying all of these numbers together from Speckman's original report. Schippert distributed the summary sheet to the committee for their review.

Schippert reported \$113,000.00 is currently owed to the Health Department by the state.

As there was no further business to come before the committee, it was moved by Jed Whitlow and seconded by Bret Schmid to adjourn at 10:35 A.M.

Your Committee met at the Courthouse on September 7, 2016 at 3:00 P.M. Members present were John Shure, Lyle Behrends, Ernie Curtis, Jean Hiles, Vince Lamie, and Jed Whitlow. Donna Crow was absent. Also present Sheriff Derek Hagen, Coroner Bill Cheatum, State's Attorney Jim Devine, Circuit Clerk Lisa Hines, 911 Director Nita Dubble, Judge James Kinzer, Probation Supervisor Barb King, County Board member Larry Hasbargen, and Wendy Davis with the Times Republic.

The meeting was called to order.

There were no public comments.

Sheriff Derek Hagen's monthly report for August included:

- Patrol had 583 calls for service for the month of August
- Year-to-Date calls for service 4,315 (3% more than 2015)
- Booked-in 82 prisoners for the month of August
- Year-to-date booked in: 512
- Average Daily Population August: 23
- Average length of stay for August: 21 days
- Year-to-date average population: 19
- Year-to-date average length of stay: 12 days
- Overtime in the Jail for August was 320 hours on the schedule
- Part-time Corrections was 32 hours
- Have two deputies off on Worker's Compensation
- New Correctional Officer will start September 15th

Hagen spoke to the committee about his budget request for 5 squad cars to be replaced. In October he will review the current budget and possibly replace one or two cars this fiscal year. Three of the five cars are unmarked; one for the Sheriff and two for the detectives. Recently, one of the detectives lost power to the sirens, lights, and radio on his way to a call.

Also, Hagen spoke about the Public Safety Tax being on the ballot. He said he has had several people in the community ask him what the money will be used for. He has explained to them it has to be public safety related. Hagen recommends coming up with a plan for the \$400,000 per year that is expected to generate if the tax passes. Hiring two deputies would only amount to 20% of the \$400,000, including their benefits.

911 Director Nita Dubble gave the committee a proposed Public Safety Tax summary. There are several different programs that could benefit from the Public Safety Tax such as Code Red. If there is an occurrence that would affect a certain community or a whole county, Code Red allows you to send a text message. The cost for this is \$12,000. Dubble also spoke about next generation 911. This would be a software program connected to the phones at a cost of \$180,000. Dubble and Hagen will be out in the public promoting the Public Safety Tax but are asking the County Board for support.

District 3 has contacted Moore about a jurisdictional transfer of 2.4 miles of state slab. They have the funding available and would like to complete the transfer. Moore said 1.24 million dollars will go into MFT funds. It was moved by Hansen and seconded by Hasbargen to approve the jurisdictional transfer of 2.4 miles of state slab. Motion carried by a voice vote.
