Your Committee met at the Administrative Center on March 24, 2017 at 1:00 P.M. Members present Lyle Behrends, Charlie Alt, Kevin Bohlmann, Larry Hasbargen, Sherry Johnson, Chad McGinnis, and Barbara Offill. Also present County Board Chairman John Shure, Finance Director Anita Speckman, ESDA Director Eric Ceci, County Board members Donna Crow, Ernie Curtis, Michael McTaggart, and Marvin Stichnoth, Iroquois County resident Jean Hiles, Wendy Davis with the Times Republic and County Farm bidders Dan F. Tordai, Daniel J. Tordai, Scott Young, Art Froehling, Keith Hethke, Kenton Carley with Carley Farms, Inc., Tim Bauer with Bauer Crops and Cattle, Jerry Walker with Walker Place, Robert Storm, Terry McTaggart, Richard McTaggart, Zach Borchers, Sam Martin, Steve Huls, and Doug Chandler.

The meeting was called to order.

There were no public comments.

Management Chairman Lyle Behrends spoke about the recent changes in the contract which include the following:

- Acreage, as verified through the United States Department of Agriculture, has been changed from 402.4 to 397.47.
- Lessee must report yields by field within thirty (30) days of harvest.
- Failure to fulfill this contract may result in Lessee being unable to bid in the future.

It was moved by Kevin Bohlmann and seconded by Barbara Offill to recommend the County Board approve the changes made to the County Farm contract. Motion carried by a voice vote.

Behrends proceeded to open the thirteen sealed bids received for the County Farm. They are as follows:
