Several Board members felt the wording in the Resolution, as presented, was overstepping the County Board's authority by dictating which laws of the State of Illinois they feel public officials should enforce or not enforce in this case. State's Attorney Jim Devine confirmed he and the Sheriff both have discretion when it comes to enforcement of the laws. He voiced concerns with the wording, in that it may cause confusion to the general public as they may not realize the law will be able to be imposed even if the Resolution is approved by the County Board. Sheriff Derek Hagen also commented that as Sheriff he took an oath to uphold the laws of the State of Illinois and he made it clear that he cannot pick and choose which laws he wants to follow. After further discussion regarding the proposed Resolution, it was moved by Mrs. Johnson to send the Resolution Opposing the Firearm Owners Identification Act back to committee to work on the wording. Your Committee met at the Administrative Center on May 30, 2019 at 9:00 A.M. Members present were County Board Chairman John Shure, Lyle Behrends, Charlie Alt, Marvin Stichnoth, and Barbara Offill. Michael McTaggart was absent. Also present County Clerk Lisa Fancher, County Treasurer Kurt Albers, County Engineer Joel Moore, State's Attorney Jim Devine, 911 Director Eric Raymond, Supervisor of Assessments Bob Yergler, EMA Director Eric Ceci, County Board Member Chad McGinnis, and Wendy Davis with the Times Republic.

The meeting was called to order.

It was moved by Marvin Stichnoth and seconded by Charlie Alt to approve the agenda. Motion carried by a voice vote.

There were no public comments

The Committee Chairmen gave their monthly reports.

- County Engineer Joel Moore spoke on Highway Chairman Charlie Alt's behalf that there is going to be two lettings and discussion on a Papineau Bridge and Ashkum Slab.
- Management Chairmen Lyle Behrends reported the committee will be receiving their monthly reports. Behrends also reported there would be discussion on USDA improvements, solar project, and Administrative Center leases.
- Judicial Chairman Lyle Behrends reported they would be receiving their monthly reports.
- Tax/Planning and Zoning Chairman Marvin Stichnoth reported, there would be discussion on tax sales and a possible tax abatement request from Incobrasa.

EMA Director Eric Ceci reported to the committee he attended IESMA EMAT meeting that was a teleconference on May 3. Ceci also stated he attended IEMA meeting in Tuscola on the 16th of May. Ceci informed the committee he kept a close eye on radar concerning the severe storms on 21st, 23rd, 24th, 27th, and the 28th. Ceci informed the committee he set off the sirens the 23rd and 27th for the severe weather our county underwent. Ceci conducted damage assessment the morning of the 25th and 28th. Ceci also shared he will be hosting a LEPC meeting May 30. Ceci will be attending a public information officer class next month. Projects Ceci will be working on in the next month include the LEPC commodity flow study, LEPC table top exercise, the Illinois Capability and Assessment THIRA (Threat & Hazard Identification Risk Assessment) Tool (ILCATT), and the hazard mitigation plan.

During the update on flood matters County Board Chairman John Shure stated he attended the Kankakee River Basin Commission meeting May 15. Shure said March 13 a motion was passed to support the activity going on to increase of the conservancy district to encompass the Kankakee River. Shure shared June 13 will be the last meeting for Kankakee River Basin commission. A law recently passed in Indiana terminating this organization where they can no longer meet. Lastly Shure informed the committee the House Bill 2583 was approved in the Senate yesterday.

(The Resolution Opposing the Firearm Owners Identification Act was sent back to Committee, per action taken by the full County Board at the June 11, 2019 Regular Session Meeting.)

During discussion on the FOID Card Resolution County Board member Chad McGinnis shared the bill will soon be passed and move forward to the Senate. McGinnis updated the committee on the FOID card bill including the prices being raised and will prevent anyone from transferring a fire arm along with a cost to transfer a fire arm.

It was moved by Lyle Behrends and seconded by Barbara Offill to adopt the FOID Card Resolution as presented by Chad McGinnis. Motion carried by a roll call vote.

It was discussed by the committee a check was received by the Iroquois County Health Department written to both the Ford and Iroquois Public Health Departments.

It was moved by Behrends and seconded by Alt to deposit the check received by the Iroquois County Health Department in an appropriate manner and to send 1/3 of the money to the Ford County Public Health Department. Motion carried by a roll call vote.

Shure informed the committee he received a letter from Roger Dittrich for Iroquois Memorial Hospital concerning appointments for Iroquois Memorial Hospital Board that will soon expire. Shure stated one needs to be renewed and there are two vacant appointments that Dittrich would like to appoint.

County Clerk Lisa Fancher reported there are discrepancies on the list of tax bills to be voided. She is waiting on confirmation from the Trustee regarding changes that may have to be made at the full County Board meeting.

Treasurer Kurt Albers reported he is currently working with several banks within the county to negotiate better interest rates.

Kevin Coughenour was absent. Also present County Board Chairman John Shure, County Clerk Lisa Fancher, Treasurer Kurt Albers, President/Managing Broker Whitney Strohmeier with Joseph E. Meyer & Associates, Attorney Patrick Fitzgerald, and Wendy Davis with the Times Republic.

The meeting was called to order.

It was moved by Roger Bard and seconded by Leanne Duby to approve the agenda. Motion carried by a voice vote.

The Committee reviewed the claims. It was moved by Jed Whitlow and seconded by Barbara Offill to approve the claims subject to full County Board approval. Motion carried by a roll call vote.

There were no public comments.

Whitney Strohmeier from Joseph E. Meyer & Associates gave a brief presentation on what services his company provides. He explained they do exactly what the County's current delinquent tax agent does, only hopefully better. When a tax buyer bids on a parcel at the tax sale in October the county agent acts on behalf of the county, who is a trustee for taxing bodies, and performs all the processes a required to either A) get the taxes redeemed by the original owner or B) petition the court for a tax deed on the property, if no redemption is made in 2 ½ years. Joseph E Meyer & Associates then holds a sealed bid auction annually to sell the properties and get them back on the tax rolls.

The County has had problems with the current tax agent, Ballinger Real Estate Company and is exploring a change. Mr. Strohmeier explained they will also assist the County with whatever steps need to be taken to correct outstanding errors made by the current agent.

It was moved by Offill and seconded by Whitlow to send a 120-day termination notice to our current trustee agent as of June 11, 2019. After the termination of the current contract, approve a new contract with Joseph E. Meyer Associates, Inc. Motion carried by a roll call vote.
