PUBLIC COMMENTS

Mrs. Offill spoke to the Board on behalf of her constituents in County Board District II. She attended a Gillman City Council meeting in which the Council talked about a letter and contract they received between the County and Gilman EMS, which would charge the City \$2,141.61 for 911 service. The Council members were apprehensive in signing the contract due to the fact that surrounding villages, such as Danforth, Crescent City, and Ashkum are not charged for 911 services. There was no action taken by the Gilman City Council regarding the contract. Mrs. Offill asked the County Board to look at the situation and come up with the best solution for all involved.

CHARIMAN COMMENTS

Chairman Shure told the Board the court case with the former Animal Control Warden has been settled. Also, on December 2nd Judge Kinzer signed the order to place a question on the ballot for the establishment of the Iroquois County River Conservancy District. He closed by wishing everyone at the meeting and all employees a Merry Christmas and Happy New Year.

OUTSIDE ORGANIZATION REPORTS

Mr. Alt reported that he attended the November 18, 2019 semi-annual meeting of the Iroquois County Veteran's Administration. There has been a steady increase in claims, at the time of the meeting there were 137 open claims. He listed new Board membership as follows: George Mabbitt, Ron Dudley, and Bill Betka. Beginning FY20, the Veteran's Administration office will be open from 8AM to 4PM and their budget has increased to \$69,100.

PRESENTATION FROM CHRISTOPHER BURKE ENGINEERING

Chairman Shure introduced State of Illinois Representative Tom Bennett and Scott Pelath, Executive Director of the Kankakee River Basin and Yellow River Basin Development Commission, both of whom have been involved in flood mitigation matters in Illinois and Indiana.

He then turned the floor over to Bob Barr and Siavesh Beik, with Christopher Burke Engineering, who presented their findings of the study that was done on the Iroquois River.

They began their presentation by describing the purpose of the study which was to diagnose the root causes of erosion and sedimentation and flooding, communicate the extent of risks, identify strategies addressing issues, and develop a work plan.

They found that sand load is increasing with sand bars developing. The channel in Momence is shifting, resulting in increased flooding. The development of rills along the river are also contributing factors to the erosion and sedimentation. Dredging and tree removal in Indiana has also increased flows. Major flooding has increased with climate change, increased precipitation, uncompensated impact of urban development, and an increase in tiling and drainage.

Mitigation would include NAI floodplain management so others aren't adversely impacted, otherwise known as No Adverse Impact Planning. NAI standards for development and fam drainage and projects would need to be implemented; as well as community specific flood response plans.

Chairman Shure confirmed the next step is to get the River Conservancy District approved, then a joint plan with Indiana will be necessary.

Scott Pelath, Executive Director of the Kankakee River Basin and Yellow River Basin Development Commission, told the Board their commission is focusing on keeping water upstream. They are hoping to create a storage area on a farm in Newton County, Indiana that would make the water manageable. He ended by saying nothing is imaginable without money.

ORDINANCE NO. 2019-7

AN ORDINANCE PROHIBITING CANNABIS BUSINESS ESTABLISHMENTS

(Ordinance No. 2019-7 will be recorded and placed on file in the County Clerk's Office)

Chairman Shure directed the Board members to a model ordinance as prepared by United Counties Council of Illinois. He asked Mr. McGinnis to give a background of the Ordinance that

was being presented. Mr. McGinnis began by saying on January 1, 2020 it will be legal to possess marijuana in the State of Illinois. Iroquois County has the opportunity to either allow any or all of the 6 types of business establishments as permitted by the Department of Agriculture within the unincorporated areas of the County. He said there is currently no zoning for these types of establishments and he felt it would be difficult for the County to regulate these types of businesses. He did say the Board could say no temporarily in order to develop an ordinance governing them and then revisit the matter at a later date. Mr. Whitlow and Mrs. Offill both voiced concerns with the legalization of marijuana in general. Mrs. Crow commented that she would not be opposed to a trucking or transportation company in the unincorporated area becoming a licensed transporter of cannabis. Mr. McGinnis said many counties are prohibiting the establishments and leaving it up to cities and villages for better regulation. It was moved by Mrs. Johnson and seconded to accept the Ordinance Prohibiting Cannabis Business Establishments as presented in the packet from UCCI. The motion carried by a roll call vote.

Your Committee met at the Administrative Center on November 26, 2019 at 9:00 A.M. Members present were County Board Chairman John Shure, Lyle Behrends, Charlie Alt, Barbara Offill and Marvin Stichnoth. Michael McTaggart was absent. Also present Finance Manager Jill Johnson, State's Attorney Jim Devine, County Clerk Lisa Fancher, Supervisor of Assessments Bob Yergler, County Engineer Joel Moore, 911 Director Eric Raymond, ICPHD Administrator Dee Schippert, ICPHD Administrative Assistant Taylor Eades, EMA Director Eric Ceci, Myron Munyon with Compass Insurance, County Board member Chad McGinnis and Wendy Davis with the Times Republic.

The meeting was called to order.

It was moved by Charlie Alt and seconded by Marvin Stichnoth to approve the agenda. Motion carried by a voice vote.

There were no public comments.

The Committee Chairs gave their monthly reports:

- Tax and Zoning chairman Marvin Stichnoth reported the committee will hear the standard department head reports this month and approve the FY19 levy.
- County Engineer Joel Moore reported he will be presenting a resolution for annual maintenance expenditures for the coming year.
- Management and Judicial chairman Lyle Behrends reported both committees will receive their standard reports. The Management committee will also discuss putting bids out for fertilizer for the County Farm.
- Health chairman Barbara Offill reported the Health committee will receive their monthly reports and discuss reclassification of the Animal Control wardens position.

EMA Director Eric Ceci reported last month he had been working on the Emergency Operations Plan (EOP) for the County. It has been submitted and approved. Ceci is also working on the Hazard Mitigation Plan and intends to submit it for approval in December or January to allow the County to begin applying for grants for any projects we may want to proceed with. Ceci said he attended a webinar and jurisdictions that have approved Hazard Mitigation Plans will be able to apply for Hazard Mitigation project grants in February.

County Board Chairman John Shure gave an update on flood matters in Iroquois County. Shure said he attended a KRBC-YRBC meeting in Plymouth, IN on November 21st and everything seems to be moving along very well. He encouraged everyone that has interest in the flooding in Iroquois County to attend the hearing in Judge Kinzer's courtroom on Monday, December 2nd at 1:30 P.M. regarding the proposed Iroquois County River Conservancy District.

Shure discussed the health department financial policies. ICPHD Administrative Assistant Taylor Eades said she spoke with Finance Manager Jill Johnson and both are under the impression that the policies have already been approved. Johnson stated she reviewed and printed the minutes from last year and was able to locate where the policies were approved. Shure suggested the matter be looked into further due to the confusion. Eades said ICPHD Administrator Dee Schippert will be joining the meeting within the next few minutes to discuss the matter because the policies do have to be approved for a specific grant. Johnson submitted three policies consisting of Criminal Background, Program Income, Code of Professional Conduct and Training Policy but said these

are not part of the financial policies that were approved for the County. These policies are specific to the health department.

A letter from the Department of Agriculture regarding Parks E5 and E6 swine facility was received. The letter is informational only and no action is necessary.

Senate Bill 75 pertaining to sexual harassment training was discussed. Myron Munyon with Compass Insurance distributed information from Bliss McKnight about the law that goes into effect January 1, 2020. Munyon said the outline of the training has not been released of what is expected from each entity. However, Bliss McKnight is anticipating that the training they have to offer the County will exceed expectations but their recommendation is to wait until after January 1st. Munyon suggested the committee take action on the training at the next Policy & Procedure meeting. Within that time frame, Bliss McKnight should have some interpretation from the State as to what the actual law says and what the expectations of the training is. Also, it is unclear if new hires are required to have the training within 30 days of their hire date. Munyon said later trainings would be held for employees that missed the initial training and for new hires. Policies within the County's Personnel Handbook will need revised and Munyon assured the committee Bliss McKnight can assist with these revisions as well at no cost to the County.

(The following paragraph was removed for separate consideration per action taken by the full County Board at their December 10, 2019 meeting.)

Discussion was held on the legalization of recreational marijuana. In September, the Board approved charging sales tax on any sales of recreational marijuana that might occur legally in the County. The next steps are to examine other options such as allowing individuals to grow marijuana in the County, allowing the sales of marijuana in the County and allowing individuals to manufacture products from marijuana. Shure distributed a model ordinance created by UCCI for the committee to review. Shure noted the Kankakee County Board voted not to allow sales of marijuana but he has since been informed that they are going to vote on the matter again at their next board meeting and it appears the vote will be reversed. Shure said he would like opinions from all members before a final vote is made. It was moved by Behrends and seconded by Stichnoth to send approval of the ordinance for recreational marijuana in Iroquois County to the full board for consideration without a recommendation from the Policy & Procedure committee. Motion carried by a voice vote.

Shure asked ICPHD Administrator Dee Schippert to speak with the committee again about the seminar she attended and how it will affect marijuana in the workplace. Schippert said the attorney that was speaking at the meeting recommended that our policies do not include language such as "under the influence" because it is very difficult to prove that someone is under the influence of marijuana. Their strong recommendation is to have a "drug free policy" or "no tolerance policy". It was moved by Alt and seconded by Offill to implement a drug free workplace. A roll call vote was taken. Motion carried. 911 Director Eric Raymond suggested there be a cause and effect in place once the drug free workplace is fully implemented. Shure said this will be worked out within the revised policy.

Appointments include Marvin Andris to the Zoning Board of Appeals.

Correspondence was distributed to the committee.

Further discussion was held on the financial policies. Schippert explained the meeting minutes from November 2018 show the financial policies as being approved. However, the health department did not receive these policies from CliftonLarsonAllen until December. Schippert said the policies were sent to the Health committee for approval and the committee referred the policies to Policy & Procedure for final approval but they were never approved. Also, State's Attorney

Jim Devine has reviewed and approved the policies. It was moved by Behrends and seconded by Alt to approve the updated financial policies as recommended by CliftonLarsonAllen on December 27, 2018. A roll call vote was taken. Motion carried.

The committee reviewed the claims. It was moved by Behrends and seconded by Stichnoth to approve the claims subject to County Board approval. A roll call vote was taken. Motion carried.

There was no old business.

There was no new business.

As there was no further business to come before the committee, it was moved by Alt and seconded by Offil to adjourn at 10:05 A.M. Motion carried by a voice vote.

Myron Munyon with Compass Insurance reported insurance renewals have been received except for property and casualty. The total premiums overall decreased \$4,500 from last year. Munyon also reported Bliss McKnight will be offering sexual harassment training to the County employees once the guidelines are in place.

The Department Heads gave their monthly reports. They are as follows:

• 911 Director Eric Raymond reported the telecommunicators contract is up for negotiations and the first discussions went well. The next meeting is scheduled for December 17th. The \$154,600 grant that was applied for is for the phone system

only. Raymond is working on getting the funding for this. The final round for next gen 911 is coming up and the notice of funding opportunity started November 5th. The final day for submission is at the end of February. Raymond is planning to submit for GIS and a recording system.

• County Engineer Joel reported an amendment to the budget for County Highway is needed to accommodate his line item for purchase of equipment. Trucks were ordered last year but not delivered until this year.

Shure reminded everyone of the Christman luncheon immediately following the County Board meeting on December 10th. All those planning to attend need to contact Chief Deputy Breein Suver in the County Clerk's Office. Shure also informed the committee this past Monday Judge James Kinzer signed the paperwork for getting the Iroquois County River Conservancy District on the ballot on March 17th. Shure said he is hopeful it will get passed but it is going to need the support of those involved with river issues. Sherry Johnson requested some talking points be put together to allow board members to effectively answer questions they are receiving. Shure said many of these questions will be answered at the board meeting on Tuesday during Christopher Burke Engineering's presentation.

Finance Manager Jill Johnson reported she met with Hope Wheeler with CliftonLarsonAllen to review budget amendments. The Sheriff's Maintenance & Repair line needs amended to reflect the roof insurance reimbursement in the amount of \$92,497.82. An entry error for IMRF County Share was made and should be at \$600,000. Lastly, County Highway's Purchase of Equipment line needs amended for \$248,210.70. It was moved by Sherry Johnson and seconded by Marvin Stichnoth to amend the FY19 budget to reflect the changes as follows:

- Fund 110-210-79010: Sheriff's Maintenance & Repairs line amend due to insurance reimbursement of \$92,497.82.

- Fund 610-815-81200: County Highway's Purchase of Equipment line amend per Joel for \$248,210.70.

The committee discussed fertilizer bids for the County Farm. The list of vendors was revised. It was moved by Alt and seconded by Paul Ducat to mail letters to vendors to receive fertilizers bids for the County Farm. Motion carried by a voice vote.

Maintenance Supervisor Chris Drake's report included the following:

- The back door of the Jail has been replaced with a steel door. The previous door was an 8 foot glass door.
- A new salt spreader was ordered because the salt spreader on hand was broken.
- Drake purchased a dehumidifier for the ammunition room in the Jail.
- Drake is meeting with a technician regarding the chiller. They will discuss troubleshooting for the chiller to avoid service calls.
- At the Administrative Center, one of the older heatpumps had a high pressure switch that needed replaced.

There were no updates on the USDA improvements.

City of Watseka Wastewater Supervisor Greg Marks and City of Watseka Building Inspector/Code Enforcement Eric Brandt were in attendance to discuss the City of Watseka flooding project. They noted there were no updated costs on the project but it was believed that the option to route the storm sewer behind the jail is what is being suggested. Sherry Johnson also mentioned grant funds that may be able to cover this project and asked if Mayor John Allhands had looked into this. Mr. Marks and Mr. Brandt said they will confirm with Mayor Allhands what information he has received regarding the grant funding. It was moved by Zumwalt and seconded by Johnson to table discussion on the City of Watseka flooding project until the next meeting, allowing us to determine grant availability, costs, elevations and long term lease options. Motion carried by a voice vote.

Overall, Joe Young requested pricing for Illinois Century Network and the cost with AT&T if we move to Illinois Century Network. Also, Young asked Taber to research an unlimited package for long distance calling with AT&T.

Taber reported the email upgrade project is almost complete with the exception of some cleanup tasks. Email security was also upgraded recently. Johnson provided a statistics report from AreaWide. Taber reviewed the report which shows in 65 instances someone tried to email malware to the County.

There are some servers that will need upgraded. The next planned upgrade is for the Devnet server at a cost of \$4,712.47. It was moved by Shure and seconded by Bowers to approve the Devner server upgrade in the amount of \$4,712,47. A roll call vote was taken. Motion carried.
